I understand an application has been made for a variation to the existing Alcohol Licence to include a Basement Bar.

No planning permission has been granted for use of the Basement.

My company DGS Developments (a private family company) are the Landlord of :-

197 Kettering Road (adjoining the applicant property) consisting of :-

Lower Ground Floor flat.

The living accommodation - Bedroom and Lounge is the other side of the party wall to the proposed 'Basement Bar'.

1st Floor flat. 2nd Floor flat.

195 Kettering Road :-

Lower Ground Floor flat. 1st Floor flat. 2nd Floor flat.

102 Hood Street :-

A Bungalow adjacent to No. 199.

I Object to the Application on behalf of DGS and the occupants (present and future) of the residential units for the following reasons :-

1) No.199 Kettering Road has no outside space for either Staff or Customers.

This already results in annoyance / disturbance from customers of No. 199 using the entrance door way of adjoining the properties 197 and 195 as 'Smoking Shelters' especially in wet and cold weather. During fine weather the adjacent footpath is the default 'smoking area'. This Public Nuisance will most certainly increase if the Application is approved.

2) Persons leaving and / or congregating outside the premise are a possible Disorder Concern.


3) The Basement of No.199 shares a party wall with the Lower Ground Floor Flat - No.197 Kettering Road.


- 4) No.102 Hood Street is occupied by a family including young children age 4 year and 1 year.
- 5) I understand that the Police and Environmental Health have expressed concern in their comments to the Planning Application, which although submitted some months ago appears to be on hold.
- 6) The increase in traffic 'dropping off' and collecting customers at the Hood St. / Kettering Rd. Junction is a Public Safety concern, the associated noise of persons and vehicles will create a Public Nuisance and disturb the occupiers of nearby homes. Vehicle parking in the surrounding area, especially at evenings and weekend is already a problem.

ANNEX 1 - MANDATORY CONDITIONS

Mandatory conditions where licence authorises supply of alcohol

- (1) No supply of alcohol may be made under the premises licence -
 - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

ADDITIONAL MANDATORY CONDITIONS.

The following mandatory conditions are to be applied to the licence stated above in accordance with section 3 (1) of The Licensing Act 2003 (Mandatory Licensing Conditions) Order 2010.

The following conditions shall come into force on 6th April 2010

1. (1) The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

(2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carrries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children-

(a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-

(i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the perod in which the responsible person is authorised to sell or supply alcohol), or

(ii) drink as much alcohol as possible (whether within a time limit or otherwise);

(b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or

discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in seciton 159 of the Act;

(c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the pruchase and consumption of alcohol over a period of 24 hours or less;

(d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on-

(i) the outcome of a race, competition or other event or process, or (ii)the likelihood of anything occurring or not occurring;

(e) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.

2. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).

3. The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.

The following mandatory conditions are to be applied to the licence stated above in accordance with section 3 (1) of The Licensing Act 2003 (Mandatory Licensing Conditions) Order 2010.

The following conditions shall come into force on 1st October 2010

4. (1) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.

(2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

5. The responsible person shall ensure that-

(a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having ben made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-

- (i) beer or cider: 1/2 pint;
- (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii) still wine in a glass: 125 ml; and

(b) customers are made aware of the availability of these measures.

Licensing Objectives

Below are the additional steps that you have agreed to undertake to promote the four Licensing Objectives and which form a part of the operating schedule for these premises: -

CCTV will be in operation & member of staff will be trained how to use the system. A sign will be located next to exit requesting customers to leave quietly. No drinks will be allowed outside. "Challenge 21" will be in operation.
