**Please state the ground(s) for review** (please read guidance note 1) I act on behalf of the Chief Officer of Police for Northamptonshire Mr Lee, and call for the Review of the Premises Licence for Body Fuel situated on Kingsley Park Terrace in Northampton.

The Review is called under the Licensing Objective of the Protection of Children from harm.

A brief history of the premises which is recorded on Northamptonshire Police's Licensing Database. This incidents that are mentioned in these papers are relevant to the Licensing Objective under which this Review is called.

On the 17<sup>th</sup> of October 2010 Northamptonshire Police conducted a Test Purchase operation at the premises in relation to underage sales of alcohol. The member of staff present sold alcohol to the two Test Purchaser's who were both under the age of 18 years. The seller was dealt with by way of a Penalty Notice for Disorder for the offence of Section 146 of the Licensing Act 2003.

On the 4<sup>th</sup> of May 2011 a local PCSO dealt with a 15 year old youth on the Racecourse which is in the immediate vicinity of the premises. The PCSO confiscated a bottle of alcohol from the youth who stated that he had purchased it from Body Fuel. The PCSO visited the premises and spoke with the member of staff present who denied any knowledge of this sale when informed about it by the PCSO. On the 6<sup>th</sup> of May 2011 the same PCSO had cause to visit the same youth where he resided. The youth stated that the previous evening the 5<sup>th</sup> of May 2011 he again visited Body Fuel and purchased alcohol, the youth stated that it was easy to buy as none of the staff ask for ID. Northamptonshire Police cannot verify that these sales took place, only that the conversation with the youth took place. The name of the youth is kept on the Northamptonshire Police Licensing Database and other Police systems however is not mentioned in these papers as the hearing is a public hearing. In addition this information is disclosed to the Licensing Sub Committee as it will assist in giving a more holistic representation of the premises. It will be down to the

committee on the balance of probabilities as to how much weight if any it regards this information.

On the 13<sup>th</sup> of May 2011 Northamptonshire Police conducted a Test Purchase operation at the premises in relation to underage sales of alcohol. The member of staff present sold alcohol to the two Test Purchaser's who were both under the age of 18 years. The seller was dealt with by way of a Penalty Notice for Disorder for the offence of section 146 of the Licensing Act 2003.

In July 2011 another Test Purchase operation was conducted at the premises on this visit the Test Purchaser's were not sold alcohol.

On the 7<sup>th</sup> of December 2012 Northamptonshire Police conducted a Test Purchase operation at the premises. The member of staff present at the time sold alcohol to the two Test Purchaser's who were both under the age of 18 years. The seller was dealt with by way of a Penalty Notice for Disorder for the offence of section 146 of the Licensing Act 2003.

On the 22<sup>nd</sup> of February 2013 Northamptonshire Police conducted a Test Purchase operation at the premises. The member of staff present sold to the two Test Purchasers who were both under the age of 18 years. The seller was dealt with by way of a Penalty Notice for Disorder for the offence of section 146 of the Licensing Act 2003.

Due to the two most recent sales being within 3 consecutive months the more serious offence of Persistently Selling Alcohol to minors, section 147a of The Licensing Act 2003. Northamptonshire Police have offered the Premises Licence Holders the option of accepting a section 169a(2) Closure Notice for Persistently Selling Alcohol to Children, this is contained within the Licensing Act 2003. This would be an alternative to prosecution and the closure would last 14 days. The notice would have been served week commencing the 15<sup>th</sup> of April 2013 and at the hearing Northamptonshire Police will be in a position to inform the Licensing Sub Committee of the outcome.

Northamptonshire Police are aware that the links between anti-social behaviour and disorder and underage sales of alcohol are well documented. Insuring that alcohol is sold and consumed responsibly is a key priority for Northamptonshire Police, all to often young persons who have consumed excessive amounts of alcohol are either directly involved in crime and disorder or are the victims of crime.
