In addition to the Mandatory Conditions contained within the Licensing Act 2003 at that time the following Police Conditions were applied:

#### POLICE CONDITIONS

The operator of a premises, designated premises supervisor or duty manager shall maintain a register indicating the name of the person in charge of the management of the premises, numbers of staff, performers (where appropriate), and door supervisors and/or security staff, where appropriate, including names and SIA licence number of SIA registered door supervisors and/or security staff who are present when the public are present.

Further, the register will contain details regarding any incident relevant to the four licensing objectives. This register shall be produced immediately on the request of an authorised officer.

The operator of the premises shall ensure that bottles, glasses and other open containers are not taken from the premises unless this practice is specifically authorised by the premises licence.

No bottles which contain drinks of any kind, whether open or sealed, shall be given to customers on the premises, whether given at the bar or by staff at table service away from the bar; and

No customers carrying open or sealed bottles shall be admitted to the premises at any time that the premises are open to the public.

At peak times and critical times, that is when the licensing objectives namely the prevention of crime and disorder and/or public safety is or is likely to be compromised, any capacity limit is maintained so as to be conducive to the keeping of good order at the premises.

The operator of the premises shall co-operate fully with any agency to ensure that the promotion of the licensing objectives is actively supported by the use of crime prevention notices and the similar.

The operator of the premises has a positive responsibility to monitor incidents relevant to the licensing objectives and must introduce and actively implement control measures, which are necessary to prevent offences of drunkenness and disorder being occasioned.

To prevent incidents of crime and disorder an expectation prevails that the operators of premises and their staff will at all reasonable times co-operate fully with the Police and other enforcement agencies and shall take steps to ensure that members of their staff understand the importance of the responsibility they hold.

On the 19th of April 2007 the Premises had a change of Designated Premises Supervisor to a Mr Jonathan BARNES.

On the 25th of February 2008 the Premises had a change of Designated Premises Supervisor reverting back to Mr David RANDALL.

On the 16th of July 2010 the Premises had a change of Designated Premises Supervisor to a Mr Barry HUNT.

On the 7th of October 2011 the Premises had a change of Designated Premises Supervisor to a Mr Jason Kelly.

On the 10th of December 2012 the Premises had a change of Designated Premises Supervisor to a Mr Johnny SIMPSON.

For clarity during all of the Designated Premises Supervisor changes Mr David RANDALL has remained as the Premises Licence Holder.

In addition to the change of Designated Premises Supervisor to Mr Johnny Simpson on the 10th of December 2012 a Variation of the Premises Licence was also made, the times and permitted activities are as follows:

Additional conditions were agreed between the applicant Mr David Randall and Northamptonshire Police and applied to the Premises Licence, details of these conditions are below:

No admissions to the premises are allowed after 3 a.m.

That on Fridays and Saturdays from 23:00hrs until the close of business, at least two SIA registered door supervisors be employed and performing the role of door supervisors at the premises

To maintain and utilise a CCTV system recording 24hrs per day with recordings kept for 28 days.

The Northamptonshire Police Licensing Database has recorded on it's system a total of 3 incidents since 2010. Since the Variation for extended trading hours, and change of Designated Premises Supervisor application on the 10th of December 2012, there have been 13 incidents at the premises to June this year.

On the 28th of December 2012 at 03:00am Police Officers were called to a report where Door Staff had detained a male on the floor. This was called through by the Door Staff via the 'Publink Radio System'. On attendance by the Officers all person's involved were spoken with and a male was arrested for being drunk and disorderly. One of the Door Staff had a cut to his eye and was spoken to about how this happened. It transpired that the arrested male had punched the member of Door Staff before being detained on the floor. The Door Staff member refused to make a complaint of assault or make a statement. The member of Door Staff stated that he was more than happy that the offender was taken away and that was punishment enough.

On the 6th of January 2013 at 04:00am a male called Police stating that he had been assaulted by members of Door Staff at the premises. When Police Officers spoke with the male he stated that he had been asked to leave the premises after Door Staff believed him to be a drug dealer. The male has then left the premises holding a glass bottle from the premises. Door Staff have then gone over to the male to retrieve the bottle at which point the male has become aggressive allegedly threatening the Door Staff member stating he would smash the bottle over his head. The Door Staff member has then punched the male to the face claiming self defence. The member of Door Staff was spoken with an dealt with by way of a Community Resolution (which can be explained in more detail at the Hearing). The fact that the member of

Door Staff has accepted a Community Resolution is an acceptance of guilt in respect of assaulting the male and brings into question whether the events happened as detailed. The argument being put forward that if it was self defence why has the member of Door Staff admitted to an assault. The Licensing Committee can put whatever weight they wish to the detail of this incident. What can be proven though is that an assault happened and the offender was a member of Door Staff. On the 19th of January 2013 at 02:30am a male states that he was shoved by door staff, as he believed his friend was unlawfully ejected form the premises, I have no further details of the incident.

On the 26th of January 2013 at 03:45am a male is ejected from the premises as he has fallen asleep in the premises. This male then sneaks back into the premises via the rear smoking area and is seen by Door Staff who physically remove him from the premises. The male states that he has been assaulted but no visible injuries are seen on the male by Police Officers.

On the 7th of February 2013 at 22:45pm a female fell from the upper balcony inside the premises after climbing over the balcony herself. On arrival Police Officers state the whole of the premises was thick with smoke from a smoke dispensing machine. In the Police Officers opinion the amount of smoke present was dangerous, visibility was reduced to near zero. The DJ was still playing music and when Officers went to ask for the music to be turned off and the smoke machine turned off so that they could deal with the incident, Officer state that this request was refused. Only once this request was reinforced again by the Officers was compliance gained. On the 23rd of February 2013 at 02:30am two females are assaulted outside the premises by a male another male intervenes and is also assaulted it is alleged by the victims that the Door Staff stood and watched.

On the 24th of February 2013 Police Officers were dealing with a violent male in St Peters Way car park who had come from Lost. At the same time Police Officers see Door Staff from Lost struggling to eject a female customer and go over to assist the Door Staff. The female is compliant with Police Officers and leaves but claims she has been assaulted by the Door Staff. This assault constituted being picked up and carried from the premises. The member of Door Staff spoken to was very anti police. The Officer concerned offered the Door Supervisor advice regarding asking for assistance from Police Officers as they were outside the venue and could have helped and prevent the situation from escalating. It was explained to the Door Supervisor that this would have prevented him form being put in a position whereby allegations could be made against him. Again the Police Officer reports that the Door Supervisor was anti police and stated "I don't have to kiss your arse just because you're the police". The Police Officer informed the Door Supervisor that the female had agreed to leave peacefully after being asked by Officers. The Door Supervisor stated that the female should have just been dragged out. The Police Officer tried to explain the justification for such force used in this situation and that tactical communications was the first option. The Door Supervisor replied that the Police should be doing more. The Police Officer asked to see the Door Supervisors S.I.A. badge and was told that he was not on duty and that the premises was closed so he did not need to wear it. The Door Supervisor then went to state that he had been attempting to remove the female for the last 20 minutes so the premises would have been open at the time the incident started. The DPS was spoken to by Police Officers and was embarrassed by the conduct of the Door Supervisor and stated he would take the matter further. From this incident a meeting was arranged attended by the Premises Licence Holder Mr RANDALL and the Designated Premises Supervisor Johnny SIMPSON with PC 113 BRYAN and PS 1056 WORTHINGTON from Northamptonshire Police Licensing Department this took place on the 7th of March

On the 29th of March 2013 at 03:06am a male is ejected from the premises for being drunk. He then becomes threatening towards his own friends and Door Staff restrain this person on the floor.

On the 20th of April 2013 at 01:20am a male was observed after leaving the outside

area of the premises squaring up to another male, when Police Officers arrive the male ran into the car park picked up a traffic cone and threw it. This male was dealt with by way of a Section 27 Direction to leave the locality (this power can be explained to the Licensing Committee in further detail at the Hearing). This male breached the Section 27 notice 20 minutes later and was arrested.

On the 20th of April 2013 at 04:25am an argument takes place between two females within the smoking area of the premises. One of the females is arrested for Common Assault.

On the 3rd of May 2013 at 01:50am a male is detained inside the premises for possession of a Class A drug by Door Staff. This male resisted arrest and assaulted Police Officers whilst being arrested.

On the 5th of May 2013 at 03:30am a female is ejected from the premises for violent behaviour by Door Staff the female then challenged the Door Staff however had left the area prior to Police Officer arriving.

On the 15th of May 2013 at 02:55am a female was attacked on the dance floor by two females, one pulled her to the ground by her hair, she managed to get back up and the second female pulls her back to the ground by her hair. The female is punched to the face several times. The two offending females then went onto smash a window of the premises, both were arrested.

On the 18th of May 2013 at 03:45am a female exits the club to talk to a friend outside who was on her phone. She is then refused back into the premises as Door Staff state that she is intoxicated. An altercation takes place whereby the female spits at the Door Staff. CCTV evidence that will be available for the Hearing so the Licensing Committee can view the incident will show a female leaving the premise by the front door and talking on her mobile phone, she then becomes embroiled in a argument with the Door Staff, a few minutes later this female is joined by a second female and it seems from the body language of the Door Staff that they are 'goading' the females. Then one of the females spits at one of the Door Staff. At this a member of Door Staff in a yellow high visibility jacket spits back at the female. The female then spits back at the member of Door Staff and moves away. The member of Door Staff then runs around the edge of the barriers at the front of the premises to spit back at the female. Again the female spits at the Door Staff member and again the member of Door Staff spits back. The member of Door Staff must spit 3 to 5 times at the female in response to her spitting. The CCTV will then show the female rushing towards the barriers and another member of Door Staff punching the female in the face sending her flying backwards. I can elaborate about this incident at the Hearing when showing the Licensing Committee the CCTV footage.

On the 25th of May 2013 at 01:40am a female attends the premises where she see's her ex partner inside. For reason unknown the female goes into the smoking area where the ex partner is, this person (ex partner) is then ejected by the Door Staff, the assumption is that an argument took place between the two. The female remains in the premises and ten minutes later again in the smoking area of the premises the ex partner approaches the smoking area shouting abuse and spitting at her.

On the 25th of May 2013 at 01:50 Door Staff detain a male for making threats towards a female. The male is arrested for being drunk in a public place.

On the 25th of May 2013 at 02:30am Police Officers have identified shouting coming from the area of the premises. Officers have then seen pushing and shoving at the location and request more Officers to attend the area. There had been a fight between an unknown group and the Door Staff.

On the 25th of May 2013 at 03:10am a member of Door Staff is assaulted at the premises.

On the 9th of June 2013 two incident took place at the premises which has been captured on CCTV. The first incident took place at approximately 05:00am, the CCTV will show a male wearing blue denim jeans, a white shirt and a blue jacket pushing another male who is dressed in black and a scuffle takes place between the pair. The male in the white shirt seems to be with the Door Staff at this time and no attempt is made to intervene by the Door Staff. The male in the white shirt then goes inside the

premises and comes out moments later with what appears to be a mobile phone in his hand. He approaches the male who he has been fighting with and raises his hand with the mobile phone in, he then squares up to the male and the male dressed in black then punches him. At this stage two of the Door Staff approach the male dressed in black and start punching and kicking him in what seems to be an unprovoked attack. The male in black can be seen to be kicked whilst on the ground then picked up by the Door Staff and removed to a nearby alley. The CCTV then shows the Door Staff returning to the front of the premises. Moments later the male in the white shirt goes into the alley way and continues to assault the male dressed in black. I will be able to elaborate on this incident when showing the CCTV footage to the Licensing Committee.

The second incident too place at approximately 05:40am, this incident involves a female in a pink dress. The CCTV will show this female upset and being 'taunted' by the male in the white shirt from the earlier incident. A member of Door Staff appears to be laughing and joining in. The female in the pink dress then slaps the male Door Supervisor to the face, in response the Door Supervisor punches the female in the face causing her the stubble sideways, the female then approaches the Door Supervisor again and she is kicked in the stomach by the Door Supervisor causing her to double over, she then walks away from the premises holding her stomach, again I can elaborate when showing the CCTV.

Northamptonshire Police have grave concerns in respect of the general management of the premises and an increase in regularity of incidents at the premises since extended trading hours were granted. Although some of the incidents detailed are neutral in respect of the conduct of the Door Staff I have had cause to speak to the Premises Licence Holder back in February 2013. This was at a meeting of the Northampton Pubwatch scheme. Northamptonshire Police had taken reports that could not be verified however were from more that one source that the Door Staff were letting customers into the premises after 03:00am in breach of their condition on their Premises Licence. I stated that Mr RANDALL needs to reinforce this with his Door Staff and inform his Designated Premises Supervisor of our conversation. On the 4th of May 2013 at 03:30am a plain clothed Police Officer observed people entering the premises via the smoking area. The people would move the barriers to one side and enter the premises. Door Staff would regularly leave these barriers unattended and the people were coming from the are of Woolmonger Street or another neighbouring premises. Between 03:30am and 03:50am the Officer observed approximately 5 to 6 people enter the premises in this fashion. On the 7th of March 2013 another meeting was arranged to discuss the issues surrounding the Door Staff not performing their functions properly and patrons being admitted after 03:00am. The Designated Premise Supervisor Mr Johnny Simpson was also present.

On the 25th of June 2013, the Police Licensing Department received an E-mail from a concerned Police Officer in respect of the general operation of Lost. The E-mail which will be available at the Hearing details concerns relating to obtaining CCTV from the premises. The Officer states that in the investigations he has personally been involved in the premises has told the Officer that CCTV is available however it is never available when the Officer requests it. In addition most incidents happen around the front door area and the Officer has been informed by staff at the premises that they have limited camera's and no camera's covering the entrance. The Officer also reports that he dealt with an arrested person from the premises (details of incident have already been mentioned). The arrested person was detained by Door Staff because they thought he was in possession of a stolen mobile phone. They robustly detained the male and the male resisted this. No mobile phone was found however Door Staff found two bags of white powder on the floor nearby so he was detained for the Police to arrive. On Police arrival, the male was still being pinned to the floor and was struggling with Door Staff. Police Officers arrested the male and in the process one of the Officer was bitten on the knee (no injury caused). Three hours later the premises reported that this male had also damaged a pane of glass in the

front door area. On interview the male denied the possession of the drugs found nearby or causing any damage to the premises, however he did admit to biting 'someone'. The reason he gave for this was that at the time he had been pinned down by Door Staff it had been for sometime and he was struggling to breath, he was struggling violently because he was panicking and literally fighting for his life. The male was given Police bail whilst the investigation was conducted and to check the premises CCTV. As already mentioned by the Officer there have been issues surrounding obtaining CCTV, and again in this incident there was no CCTV recordings available from the premises. In addition the two Door Supervisors involved in the incident that the Police Officer had names for did not respond to numerous calls requesting for statements, the male has had no action taken against as there is a clear lack of evidence. The investigating Officer contacted the Police Officer who was bitten to update them and this Officer disclosed that he had not been happy about the incident also. The Officer stated that the two bags of drugs were packaged differently and in the Officers opinion did not appear to come from the same source. The Officer also found it odd in their opinion that the Door Staff had forcefully detained the male to search him for the alleged stolen mobile phone (no legal power to do this); the Door Staff have then not found a mobile phone but then reported that two bags of drugs were on the floor next to him. Northamptonshire Police are of the view that currently the operation of the premises does not promote the Licensing Objectives of the Prevention of Crime and Disorder and Public Safety. There have been a number of incidents on a regular basis and the conduct of the Door Staff working at the premises falls far below the expectations that Northamptonshire Police would expect. Northamptonshire Police are so concerned in respect of the operation of this premises that Northamptonshire Police would like the Licensing Committee to consider the following conditions and sanctions:

- 1) A reduction in hours for trading and all licensable activities to 02:00am, with a 30 minute 'drinking up period' prior to close of business.
- 2) That all Door Supervisors (which can be named at the Hearing) are no longer employed in any capacity at the premises.
- 3) That all Door Staff at the premises shall wear high visibility jackets or shirts including T-shirts or Polo's when working at the premises in the capacity of a Door Supervisor, inside and outside of the premises.
- 4) That Body Worn Video either a 'chest' mounted camera or a head camera be worn by at least two Door Supervisors when working at the venue. One to cover the inside of the venue and one to cover the outside of the venue. Recording will be made available to Police Officers on reasonable request and recordings must be kept for 28 days.
- 5) Door Supervisors at the venue must sign into a register before the commencement of their shift. The details must include their 16 digit S.I.A. licence number, their full name and their date of birth.
- 6) That a member of Door Staff will be positioned within the smoking area of the premises from 10:00pm until close of business.
- 7) That all Door Supervisors employed at the premises wear their S.I.A. licence in a high visibility armband.
- 8) That there be a removal of the current Designated Premises Supervisor.
- 9) That a Personal Licence Holder be present and working at the premises from

- 10:00pm when the premises is open to the public.
- 10) That a CCTV camera be fitted at the premises that covers the front door area of the premises and that recordings be kept for 28 days. In addition that these recordings are available to Police Officers on reasonable request.
- 11) That there be a period of suspension of the Premises Licence in order for the Premises Licence Holder to make arrangements to implement the proposed conditions. In addition Premises Licence Holder can put his 'house in order'. I can give further details as to why Northamptonshire Police have asked the Licensing Committee to consider this at the Hearing.

Northamptonshire Police are of the view that these proposed conditions be considered, however the wording of the conditions are subject to change should the Licensing Committee decide to add or amend, or ultimately decide on a different decision.








#### 19 Mandatory conditions where licence authorises supply of alcohol

- (1) No supply of alcohol may be made under the premises licence -
  - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
  - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

#### ADDITIONAL MANDATORY CONDITIONS.

### The following conditions shall come into force on 6th April 2010

- 1. (1) The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carrries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children-
- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-
- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the perod in which the responsible person is authorised to sell or supply alcohol), or
  - (ii) drink as much alcohol as possible (whether within a time limit or otherwise):

- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in seciton 159 of the Act;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the pruchase and consumption of alcohol over a period of 24 hours or less;
- (d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on-
  - (i) the outcome of a race, competition or other event or process, or
  - (ii)the likelihood of anything occurring or not occurring;
- (e) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
- 2. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 3. The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.

The following mandatory conditions are to be applied to the licence stated above in accordance with section 3 (1) of The Licensing Act 2003 (Mandatory Licensing Conditions) Order 2010.

### The following conditions shall come into force on 1st October 2010

- 4. (1) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
- (2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.
- 5. The responsible person shall ensure that-
- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having ben made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-
  - (i) beer or cider: 1/2 pint;
  - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
  - (iii) still wine in a glass: 125 ml; and

(b) customers are made aware of the availability of these measures.

#### **POLICE CONDITIONS**

The operator of a premises, designated premises supervisor or duty manager shall maintain a register indicating the name of the person in charge of the management of the premises, numbers of staff, performers (where appropriate), and door supervisors and/or security staff, where appropriate, including names and SIA licence number of SIA registered door supervisors and/or security staff who are present when the public are present.

Further, the register will contain details regarding any incident relevant to the four licensing objectives. This register shall be produced immediately on the request of an authorised officer.

- 2. The operator of the premises shall ensure that bottles, glasses and other open containers are not taken from the premises unless this practice is specifically authorised by the premises licence.
- 3. No bottles which contain drinks of any kind, whether open or sealed, shall be given to customers on the premises, whether given at the bar or by staff at table service away from the bar; and No customers carrying open or sealed bottles shall be admitted to the premises at any time that the premises are open to the public.
- 4. At peak times and critical times, that is when the licensing objectives namely the prevention of crime and disorder and/or public safety is or is likely to be compromised, any capacity limit is maintained so as to be conducive to the keeping of good order at the premises.
- 5. The operator of the premises shall co-operate fully with any agency to ensure that the promotion of the licensing objectives is actively supported by the use of crime prevention notices and the similar.
- 6. The operator of the premises has a positive responsibility to monitor incidents relevant to the licensing objectives and must introduce and actively implement control measures, which are necessary to prevent offences of drunkenness and disorder being occasioned.
