The Committee decided unanimously that on a balance of probability the Applicant was not a fit and proper person to continue to be licensed as private hire driver and therefore the license was revoked.immediately pursuant to Section 61 (2B) Local Government (Miscellaneous Provisions) Act 1976. This power was exercised in the interests of public safety
