**RESOLVED:**

The Committee decided unanimously that on a balance of probability the Applicant was not a fit and proper person to be licensed as private hire driver and therefore refused the license application.

**9. REVIEW OF COMBINED DRIVER LICENCE**

The Licensing Enforcement Officer outlined the circumstances as set out in the report and explained that the licence holder had been provided notice of the hearing. The committee decided that the licence holder had not provided a satisfactory explanation for not attending the committee and the committee decided unanimously to proceed with the hearing in his absence.

The Committee reached a decision with regard to any further action to be taken.

**RESOLVED:**

The Committee decided unanimously that on a balance of probability the Applicant was not a fit and proper person to continue to be licensed as private hire driver and therefore the license was revoked immediately pursuant to Section 61 (2B) Local Government (Miscellaneous Provisions) Act 1976. This power was exercised in the interests of public safety
