6. POLLING DISTRICTS AND POLLING PLACES REVIEW.

The Chief Executive submitted a report which outlined the final recommendations from the Local Returning Officer which related to the Review of Polling Districts and Polling Places. Following approval from the GP Committee on the 6th October 2015 for there to be a consultation, the feedback gained had been included and in the report and where appropriate to the original proposals.
