On behalf of the Chief Officer of Northamptonshire Police Mr EDENS, I call for
Review of the Premises Licence for the premises known as Bantam Cock PL0170.

I call for the review under the Licensing Objectives of the prevention of crime and disorder and public safety.

The review is called for following the accumulation of incidents of crime and disorder that have taken place at the premises over a period of time. Officers from Northamptonshire Police have worked closely with the management of the premises during this time however while temporary improvements have been made following each meeting, the general trend of incidents of crime and disorder have remained the same. Several letters documenting the police concerns have been sent to the DPS since 2015 demonstrating a stepped approach to enforcement.

The most recent incident that has caused this review to be triggered was a stabbing which took place on the 1st April 2017 at approximately 05:40hrs. In the lead up to this incident, the victim reported that the group involved in this incident were inside and had caused 5-6 fights inside throughout the course of the night. This was reported to door staff at the venue however they took no action to intervene or remove the group. The victim stated that the door staff forced everyone out of the pub together with the group without regard for the safety of the customers and that as a direct result of this an altercation took place. The victim was stabbed twice; once in the chest and once in the back. This has led to him sustaining a punctured lung and needing sugery including a chest drain.

Based on the circumstances, the suspect will on the balance of probability have brought the weapon into the premises with him and has not been searched at any

point by door staff.

The door staff that were present during this incident had been bought in to replace the previous door team on the 4th February 2017 following two incidents where complaints of assault were made against them. These incidents are still subject to a live police investigation however the CCTV footage is available to the committee to review and to aid in their deliberations.

It was also identified that between the 30th September 2016 and the 5th February 2017, there had been 19 recorded crimes of violence and theft that had taken place at the premises. This does not include incidents where official complaints were not made but incidents reported. All 19 of these incidents are reported as taking place either inside or directly outside the premises but where the involved people had been in the premises immediately before the incident took place.

Following the incident on the 4th February, a meeting was held with the DPS on the 8th February. During this meeting, a request was made to see the incident book as per the condition on the premises licence. An inspection of this book measured against the police incidents alone showed that there was a lack of compliance when it came to what was being recorded. In addition, there was very little detail in the incident reports themselves and this constituted a breach of the licence.

The number of incidents, especially violent incidents and the lack of control the security staff seem to have over the venue have demonstrated that the premises is not currently upholding the licensing objectives. Furthermore there is a clear pattern that the vast majority of the incidents are taking place in the early morning after 03:00hrs.

Please provide as much information as possible to support the application (please read guidance note 2)

It is the view of the police that the current operation of the venue is not upholding the licensing objectives of the prevention of crime and disorder and public safety. In order to rectify this, Northamptonshire Police would ask the committee to consider applying the following amendments:

- 1) To reduce the opening hours of the premises to no later than 03:00hrs daily.
- 2) To reduce the terminal hour of licensable activity to no later than 30 minutes prior to the premises closing time.
- 3) An update to the CCTV condition to state: "A fully working and maintained system capable of recording and storing images must be installed on the premises. The system must record at all times the premises is open to the public and images must be stored for a minimum of 28 days with date & time stamping. As a minimum this must cover all entry and exit points, both sides of all areas where the sale/supply of alcohol takes place, the external garden area and the curtilage of the building".
- 4) The addition of conditions around door supervisor numbers. "A minimum of three door supervisors must be present and on duty at all times when the premises is open to the public and licensable activity is taking place after 23:30hrs on a Friday and Saturday night and a Sunday when it falls before a Bank Holiday Monday. This will also apply to Christmas Eve and New Years Eve where they fall on a day other than a Friday or Saturday."
- 5) The addition of a condition: "Door supervisors employed at the venue will wear hivisibility outer garments at all times both when working inside and outside the venue.
- 6) The addition of a condition for a policy to deal with the identification of and dealing with people who are vulnerable due to their presence in the night time economy. A suggested condition is attached in the evidential bundle.
- 7) The addition of a condition for a dispersal policy that has been agreed with Northamptonshire Police to be applied.

It is the belief of the Police that these measures are proportionate and necessary when taking into account the nature of the problems identified, the risk to the public should no action be taken and the business interests of the premises licence holder. The latter must be balanced against the first two reasons.

In order to assist the committee in reaching a conclusion, Northamptonshire Police intend to introduce the following information:

- 1) A copy of the premises licence PL0170 for Bantam Cock
- 2) Three letters of correspondence to the DPS of the premises.
- 3) An evidential bundle of incidents and F60a's from police officers.
- 4) A summary of the incidents in a presentable format.
- 5) CCTV of the incident where it is alleged door staff have assaulted a customer.
- 6) Suggested condition wording for condition number 5 as above.

There are some other items that the Police may wish to introduce as evidence at a

Thank you for taking the time to meet me today to discuss the current issues that have been brought to the attention of Northamptonshire Police. I have brought the issues to your attention in the interests of transparency to highlight the serious concerns that I have with the number of incidents of crime and disorder and public safety that have been directly linked to your premises.

I have left you a copy of the summary of incidents that are directly attributable to your premises.

During the visit, we discussed the environmental issues with your venue with the toilets having a lot of graffiti on the walls and the general state of repair and tidiness in the garden area. Crime prevention advice was given in respect to the disrepair of the venue leading to further acts of damage and a general lack of respect from customers. Consideration also needs to be given for members of staff to regularly collect the empty bottles and glassware throughout the venue as this has the potential to be a danger to public safety and could contribute to crime and disorder in the event of a violent incident.

Also discussed was the number of door staff that are currently employed to work at the venue during the peak hours of Friday and Saturday nights between 00:00hrs and 06:00hrs. Given the current issues with the premises, I have requested that you write a door staff risk assessment to cover the numbers and deployment of door staff within the venue during the peak hours as mentioned. This needs to be completed within the calendar month of the date of this letter and implemented as soon as reasonably practicable.

There have also been a number of incidents of crime and disorder that have occurred immediately outside the venue. To address this, I have requested that you write a dispersal policy for customers leaving your venue that the door staff can adhere to and implement.

CCTV camera placement throughout your venue was also discussed with the entry points to the toilets and the gardens needing better monitoring in the interests of crime detection and prevention.

One of the licensing conditions for the venue is listed as maintaining a register which records the incidents that have taken place in the venue which undermine the licensing objectives. This register is not being maintained and is something that needs to be rectified with immediate effect. A register will be provided to you and the expectation will be that you complete this diligently.

The Pubwatch Scheme was discussed with you as a final point with the benefits of the digital radio system and other support that comes with membership. This was recommended to you.

I am bringing all of these issues to your attention at this time as I feel it is important to work with you to bring the venue into line with the spirit of the licensing objectives. If incidents of this nature do continue to occur without

any significant attempts at addressing the issues on your part, I will have to seriously consider a review of the premises licence.

I look forward to working with you in relation to this matter and will provide what help and support I can.

For your information, I will also be forwarding a copy of this letter to Trust Inns in order that they are fully sighted on my position at this time.

Thank you for meeting me yesterday I feel as though the discussion was productive and useful to have.

During the meeting, we discussed the incidents that had taken place at your premises prior to our last meeting in a little bit more detail. Although we didn't go through every incident, I did explain that each one was directly linked to your premises. I also explained the form 60a process and the circumstances around when these forms are completed. There was also a discussion around the timings of the incidents and the increase in the number of 60a's being completed this year compared to previous years. The discussion then moved to the incidents that had taken place following our meeting and that the incident levels are currently similar to the pattern of previous months. You have also requested that I provide you with an ongoing update of incidents as they come in and I have agreed that we will

meet on a regular basis but also we will have unplanned conversations if and when incidents of a significant nature arise.

Since our previous meeting in September, I am aware that you have joined Northampton Pubwatch and you have come to the two meetings that have been held during the interim period. As such you have now had the benefit of the list of the people on Pubwatch bans as well as having had access to some free training on responsible alcohol retailing. You have also stated that you have installed additional cameras within the premises as well as having a fourth supervisor employed on a Friday and Saturday night on a temporary basis. I have been shown a copy of both the dispersal policy and the risk assessment that you have documented. You have also outlined that you have begun banning people that have caused problems in your premises and while I have not seen the documentation to support this we will sit down and review this when we next meet.

Moving forward, we had a discussion around several areas where I felt that improvements could be made. Firstly the use of signage to advertise the fact that there is no entry to the premises after 3am as per your licence condition. I feel as though the signage may well assist your door staff when it comes to turning people away and reassures me that you are not allowing entry after this time. Secondly having reviewed your dispersal policy, I have requested that you develop it further to include the immediate area of the outside of the building as well. It was agreed for clarity that this will include the front of the premise and half of the road on Abington Square. On either side of the building, this area will extend to 10 metres either side of the edge of the building.

The final thing that I have suggested is that Northamptonshire Police are willing to provide you with an alcohol breath screening device that your door staff can use as a means to assess drunkenness when people are attempting to gain entry to the premises. This is an offer that I can now formally make to you and am hopeful that you will consider this.

You also need to make a business decision around the renting or purchasing of a digital radio to enable better communication with the other premises in the town as well as the CCTV control room. I have left this to you and while I have outlined the benefits, it is ultimately a decision for you to make based on cost vs benefit.

In conclusion I am happy with the steps you are putting into place at this time and will continue to work with you to try and help you address the issues that your premises is currently experiencing.

I hope you feel as though this is an accurate reflection of our meeting however please feel free to bring an omissions or errors to me attention.

Dear Ciaran,

Thank you for taking the time to meet with me to discuss the recent performance of your venue in terms of the licensing objectives of the prevention of crime and disorder and public safety.

My primary concern at this time is that your current door team are potentially undermining these objectives. This is reflected in the number of crimes that have been recorded in the last four months beginning with the 30th September 2016 until the 5th February 2017. There have been 19 recorded crimes in that period with all of them being either thefts or assaults. To clarify, all of these crimes are directly attributable to your premises and have occurred inside the premises. Also this figure does not include incidents of crime and disorder that for one reason or another have not been recorded as crimes. When this is put into the context of the size and capacity of your premises, this is a high level of crimes.

In addition to this, I have been made aware that the Police are currently investigating two incidents where complaints of assaults have been made against one of your door team on the same night. I know that you have also been made aware of this and while I cannot comment on the specifics of these incidents, I need to point out to you that the Licensing Team consider this to be a serious investigation. In addition to this, we feel as though this member of door staff presents a potential risk to your licence should he continue to be working at your venue. This is not just in relation to his future conduct but also in the tension his presence could cause with customers who may have

witnessed his actions during the incident. I must however stress that this information has the potential to change should the investigation shed light on the situation as it currently stands.

Over and above this however is the information I have both documented and anecdotally that your door team are not taking steps to support and protect victims of crime when they have been identified. On the 5th February, I have received a report whereby the door team have ejected a victim of crime out of your venue at the same time as the offender who was her partner. The offender has then gone on to assault the victim further causing more serious injuries. The report also states that the door team have watched and taken no steps to intervene.

Talking to you today and after reviewing your incident register, it is clear that your door team are not accurately recording the incidents that are taking place at your venue. As such it calls into question how effective they are being in preventing incidents and intervening in situations to maintain the safety of your customers.

All of this taken holistically leads me to inform you that I do not feel as though the door team are capable of performing their role effectively. It is therefore my recommendation that you take steps to replace the door team as soon as possible. While I cannot instruct you to do this, I must point out that if incidents of the nature described above continue to happen, I must give serious consideration to a review of the premises licence.

In any case I do require you to take immediate steps to ensure that the incident register is filled out in detail and accurately so that it gives a true reflection of what is occurring inside the venue. I also suggest that you ensure that your door team are aware of their responsibilities regarding duty of care and the prevention of crime and disorder.

I require you to acknowledge receipt of this letter and also to respond to me with a summary of what steps you are going to take to try and address these issues.

In the meantime if I can be any help and support please feel free to contact me directly.

REGULATORY REFORM (FIRE SAFETY) ORDER 2005 THE BANTAM 7 ABINGTON SQUARE NORTHAMPTON NN1 4AE

With reference to the fire safety audit of your premises on the 21st April 2017, I confirm that the outcome was as follows:

- No records were available at the time of the inspection to show the Fire Alarm System
 was being maintained by a competent person. As discussed the fire warning and
 detection system should be tested and maintained in accordance with the
 recommendations in British standard 5839 Part 1, which states the period between
 successive inspection and servicing should not exceed six months.
- No record of an annual test of the emergency lighting system was available at the time of the inspection. BS 5266 recommends an annual full duration discharge test should be carried in accordance with the manufacturer's instructions.

It will still be necessary to continue to review your fire risk assessment regularly (recommended to be at least once a year) and on the occasion of any of the following:-

- (a) There is reason to suspect that it is no longer valid, or
- (b) There has been a significant change to the matters to which it relates.

Where as a result of any such review, changes to an assessment are required; the responsible person concerned shall make them.

Hi Chris,

Firstly apologies for the delay in reply but as you can understand it hasn't been easy to arrange meetings etc. with everyone having full time day jobs.

Okay so following our meeting, we have decided to suspend our current door team with immediate effect. We have taken this action due to the recent complaints made to the police and the current investigations outstanding that you informed me about on the 8th February. We have also decided that the suspension will continue until we hear of an outcome with regards to the accusations made.

We have used the same door company since we started in 2010. We also have had the same door staff, since we started and started 4 years ago. Like I said to you in the meeting, we haven't had serious allegations like these against these door staff before and it seemed very out of character for them. That being said, obviously we support any investigation by the police into allegations that are made.

I have spoken to the door staff about the incident on 5th February, they have told me that the couple where bickering and arguing, which followed on with the female slapping the male inside the premises and then the male slapped the female back. When confronted by the door staff they where told by both parties that it was okay and they where together so they where asked to leave. At no point when asked or otherwise did the female or male express that either needed assistance or that he/she where scared or needed protection. Instead they both went outside, had an argument which went on to the male slapping the female, the door team did ask the female if she was okay and started to move the male on and they **both** again insisted everything was okay and it was between them. After 20 minutes or so they both walked off together. They have since put it in the incident book.

I would like if possible if you could put the incidents into categories, i.e. Thefts, assaults and anything that would lead you to believe the licensing objectives are not being upheld. I would like a more detailed breakdown of each incident as I think this will help all staff to understand the types of crimes and how we could potentially tackle each one. I do think however that unfortunately although it appears that there is a lot of crimes at the premises, when you look at each individual incident a good proportion of these are things that can't be foreseen or prevented.

With regards to the incident reporting, the majority of incidents have been recorded in our register, majority obviously not being good enough as all incidents should be recorded. Also it is agreed that although the main basics had been inputted, the amount of detail in the reports needed to be improved upon. The new door team has been told about this, and obviously Adam is aware to make sure this is undertaken at the end of the night.

IP goes to town with male partner where they consume alcohol. whilst in The Bantam pub, male believes female is flirting with another male so punches female to the head numerous times. No hospital treatment received

IP was playing snooker in the location and left his items on a table. During this time unknown person has taken these items. Nothing seen or heard.

Incident 99 was reported via CCTV to state that a fight was occurring outside The Bantam Public House involving two group of males which have dispersed and gone their separate ways prior to police arrival. Upon assessment by doctors it was established that he had a punctured lung and internal bleeding. Doctors have assessed it as not life threatening at this stage.
