REVIEW OF PREMISES LICENCE

Alcohol & Gambling Licensing Sub-Committee

1.0 Purpose of Report

- 1.1 To consider a request from a relevant person for the Review of the Premises Licence for The Turkish Social Club, 4 Henry Street, Northampton NN1 4JE.

2.0 Summary

- 2.1 The review application was received on the 11 September 2018 from the relevant person, Charlotte Ryan, and submitted in accordance with licensing objective(s) for;

- The Prevention of Public Nuisance.

(Appendix A)

- 2.2 The current licence holder is Cahit Menekse 6 Hilberry Rise, Northampton, NN3 5ER. The premises licence is recorded as PL1035 (Appendix B)

3.0 Consultations/Representations

- 3.1 When a request for the review of a premises licence or club premises certificate is received, the licensing authority must display a notice at or near the premises, and on the council's website. This gives responsible authorities and any other interested parties a 28 day period for the opportunity to make representations in relation to the review application. It is the responsibility of the applicant to serve a copy of the review application onto the licence holder and the responsible authorities.

- 3.2 The local authority displayed the obligatory notice on the 12 September 2018 (Appendix C)

- 3.3 During the 28 day period no representations have been received.

6.0 History of Premises & Licence Holder

6.1 The Turkish Social Club was originally granted a licence by this authority on 8 April 2014 under Premises Licence no. PL1035. A variation of the Premises licence was applied for on 3 July 2018 and subsequently granted on 11 September 2018 following a hearing at Licensing Committee on 15 August 2018. This variation allows the use of additional areas of the premises for licensable activities along with a smoking area to the rear of the premises. At the time the variation was granted the Licensing Sub-committee added the following conditions:

- (a) The smoking area shall not be used after 11.00 p.m. on any day.
- (b) All doors and windows at the rear of the premises shall be kept closed after 11.00 p.m. from Monday to Saturday and after 10.00 p.m. on

Sundays and Bank Holidays other than when it is necessary to allow access and egress of people to and from the premises. Doors must be closed immediately afterwards.

Signs shall be placed in the premises to advise customers to consider neighbouring occupiers and not to cause noise nuisance whilst in the smoking area. The Applicant may wish to display signs in both English and Turkish. Staff shall also monitor the smoking area.6.2 The Premises Licence holder Cahit Menekse was granted a Personal Licence by this authority on 28 January 2014 under licence number PA2390.

6.3. A location plan of the premises is attached (**Appendix D**). A plan showing the layout of the premises is attached (**Appendix E**).

7.0 Options

7.1 At the end of the consultation period the licensing authority must hold a hearing. It must take such steps as it considers appropriate for the promotion of the licensing objectives, which are:

- the prevention of crime and disorder;
- public safety;
- the prevention of public nuisance; and,
- the protection of children from harm.

The steps the Sub-Committee can take are to:

- a. modify the conditions of the licence;
- b. exclude a licensable activity from the licence;
- c. suspend the licence for a period not exceeding 3 months;
- d. remove the designated premises supervisor; and / or,
- e. revoke the licence.

If the Sub-committee decide to take either or both of steps a. or b. it may decide that those steps have effect for a specified period of up to 3 months.

8.0 Policy Considerations

9.0 Committee

Each application must be considered on its own merits and any conditions attached to a licence must be tailored to the individual style and characteristics of the premises and events concerned. This is essential to avoid the imposition of disproportionate and overly burdensome conditions on premises where there is no need for such conditions. Standardised conditions should be avoided and indeed, may be unlawful where they cannot be shown to be necessary for the promotion of the licensing objectives in any individual case. Any action taken in relation to this review should be appropriate for the promotion of the licensing objectives and proportionate to the issues raised.

We live [REDACTED] which is a block of terraced houses.

The Turkish Social Club have been granted a variation to their current licence and are awaiting the planning decision for a ground floor extension.

We are asking for a review of the licence in line with the licensing objective “the prevention of public nuisance” for the following reasons;

- Noise
- Opening Time of the Premises
- Smoking
- Security
- Litter
- Lighting
- Parking
- The premises being classed as a “business unit”

Noise

Our biggest concern is the noise levels. On quite a number of occasions we have posted polite notices through the door to ask them to keep the noise down which they have blatantly ignored. They are not respectful to their neighbours when they are banging doors, shouting and generally just being a nuisance especially late at night. As we are a terraced property [REDACTED]

[REDACTED] We both work 9-5 jobs and as you can imagine trying to get to sleep with the noise they are making is very difficult and affects our day to day lives. The new plans also show the new extension if granted will have a smoking area to the back of the premises, as a couple we are trying to start a family and we are concerned that the noise will also affect the rooms at the back of the premises.

Opening Times of the Premises

Another concern we would like to raise are the opening times of the premises, currently they are allowed to stay open until 2.00am which as I have stated in the previous paragraph is causing us a problem with noise. We would like to point out that in the Licence Variation hearing Councillor Graham Walker raised concerns that the current licence allowed the sale of alcohol until 2am. Mr Birch (Licence Holders Solicitor) responded "While we could stay open until 2am, I don't see this happening. We have to be sensible with our neighbours. In reality this club sells more Turkish tea than it does beer. It's a gathering place and the sale of alcohol is minimal and it's not a loud night premises". If this is the case and they don't hardly stay open until 2am and more Turkish tea is sold than alcohol then what is the need for the license and the need to have a license until that time? I would also like to point out that the premises is loud at night which I have stated in my previous paragraph.

Smoking

Smoking is also another big concern that we have. In the Licence Variation Hearing the License holder's solicitor stated "We are moving the smoking area quite a long way from Henry Street". On the new plans we have seen the extension [REDACTED] so would like some clarification on where exactly the new smoking area will be as we cannot see it will go anywhere else other than [REDACTED]. We are concerned that we are not going to be able to have our windows open at the back of the premises because of the odour of smoke. We are not smokers ourselves and find smoking and the smell of it quite disgusting. This is also a potential health hazard for a baby if the windows are open. Why should we have to keep our windows closed? One of the conditions of the Variation to the License was that the smoking area will be closed off after 11.00pm on any day, we are concerned that when this happens customers will go back to smoking outside of our property which they currently do which as you can imagine in the summer is not nice to have smoke coming through our windows. When we have politely asked people to move they have ignored us.

Litter

On a weekly basis we have to sweep outside our house because people have littered outside our window and I have watched them first hand go back into the Turkish Social Club, our bin day is a Monday and there is always rubbish outside the property before this, as you can imagine in the summer especially, it is not nice, we cannot have our Living Room window open because of the odour of rubbish. We have also had a big problem with rats which was reported and dealt with at the back end of last year, however we have had a few sightings of them since which have also been reported to Environmental Health, we feel the litter has to be dealt with and maintained so this problem does not get out of hand again and right now we cannot see any improvements.

Security

Directly next to our wall there is an old stairwell which if you walk up it you can hop over and you are onto our flat roof. We feel this must be removed so it reduces the risk of people getting into our garden.

Lighting

We feel lighting could become an issue to the back of the property. When people are out in the smoking area late at night we do not want lights blaring into the back of our property as we feel this will disrupt us.

Parking

Parking is another issue, as I am sure you are fully aware we live on a terraced street where parking is limited anyway. There has been quite a few occasions where we have had to park on other streets because there are no spaces on Henry Street, with this License Variation being granted we feel this problem will just get worse. It was noted in the Licence Variation Hearing that the Applicant offered to provide car parking spaces at the side of the premises, again we would like clarification on this.

Premises being Classed as a Business Unit

When we moved in 2 years ago, we were advised that next door was a "Business unit", whilst we are fully aware there is no legal obligation for signs to be displayed on the exterior of a licensed premises we feel that a Social Club (Licenced Premises) which is situated in a residential street should be differentiated between say a shop, if this had been made clear we may not have brought the property, we do however feel that this will now affect us when we are eventually ready to move.

ADDITIONAL MANDATORY CONDITIONS.

The following mandatory conditions are to be applied to the licence stated above in accordance with section 3 (1) of The Licensing Act 2003 (Mandatory Licensing Conditions) Order 2010.

The following conditions shall come into force on 6th April 2010

1. (1) The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

(2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children-

(a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-

(i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or

(ii) drink as much alcohol as possible (whether within a time limit or otherwise);

(b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act;

(c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;

(d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on-

(i) the outcome of a race, competition or other event or process, or

(ii) the likelihood of anything occurring or not occurring;

(e) selling or supplying alcohol in association with promotional posters or flyers on, or in

the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.

2. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).

3. The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.

The following mandatory conditions are to be applied to the licence stated above in accordance with section 3 (1) of The Licensing Act 2003 (Mandatory Licensing Conditions) Order 2010.

The following conditions shall come into force on 1st October 2010

4. (1) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.

(2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

5. The responsible person shall ensure that-

(a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-

- (i) beer or cider: 1/2 pint;
- (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii) still wine in a glass: 125 ml; and

(b) customers are made aware of the availability of these measures.

ANNEX 1 - MANDATORY CONDITIONS

Mandatory conditions where licence authorises supply of alcohol

(1) No supply of alcohol may be made under the premises licence -

(a) at a time when there is no designated premises supervisor in respect of the premises licence, or

(b) at a time when the designated premises supervisor does not hold a personal

licence or his personal licence is suspended.

(2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Conditions of Operating Schedule

The Licence Holder will ensure the promotion of the licensing objectives forms an integral part of the day to day management of the premises

A CCTV system is in operation that complies to the Data Protection Act 1988. The CCTV system is recording at all times the premises is open for business. Recordings are kept for 28 days and a person who is trained in how to use the system is on duty to retrieve recordings upon reasonable request of an authorised officer.

Bottle skips will not be emptied outside between 2200 and 0700.

A working intruder alarm is in operation.

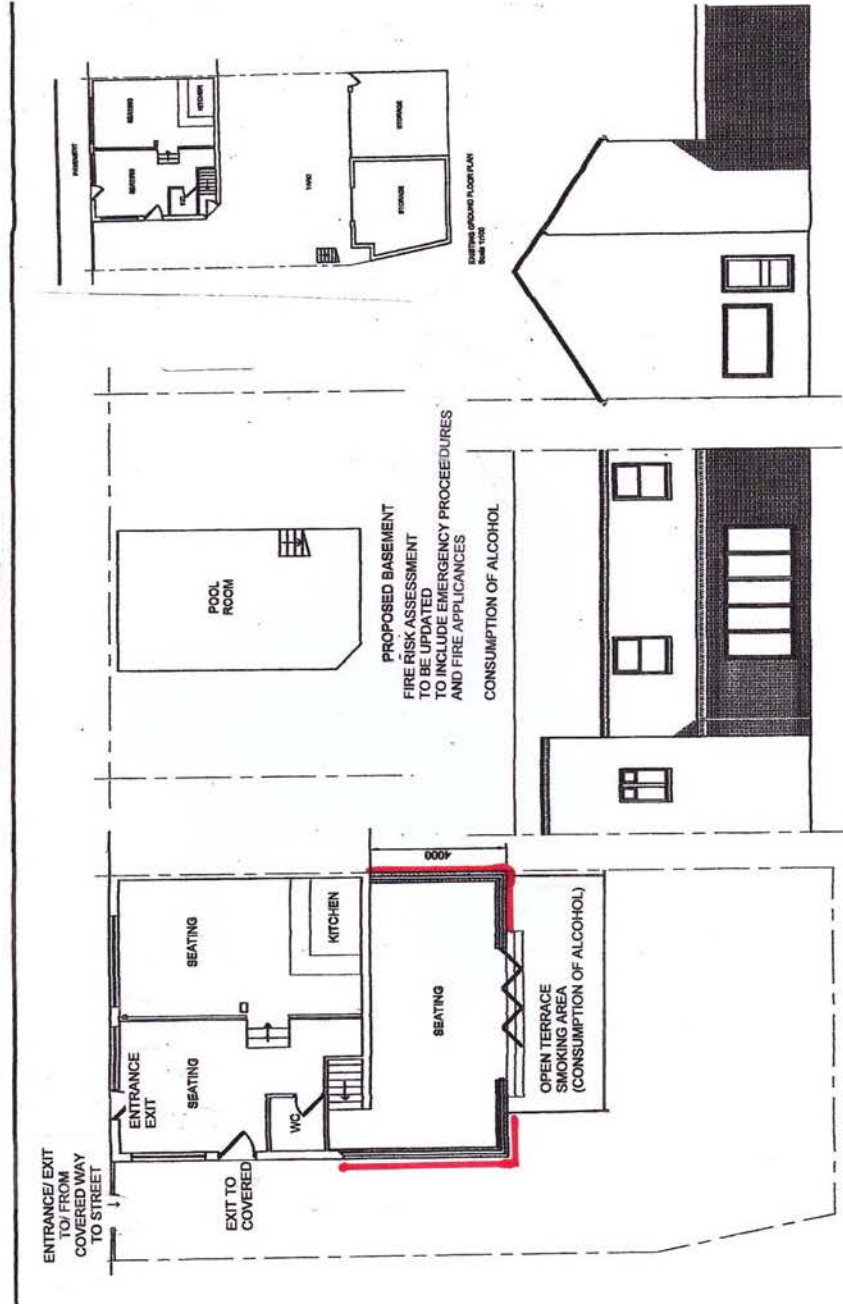
