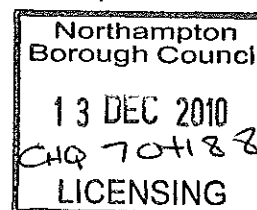

P Describe the steps you intend to take to promote the four licensing objectives:

a) General – all four licensing objectives (b,c,d,e) (please read guidance note 9)

The club is working in a joint venture with a Nationally renowned catering partner with the experience to provide high standards of care as expected by the club. We employ our own experienced safety officer who works also at Northampton Town and is responsible for maintaining our health and safety responsibility. As CEO I demand high standards in ground maintenance and customer service recognising our high visibility as a major spectator sport and also as a televised event venue. Our governing body also recognises the responsibility it has through the 18 first class clubs and does an annual audit of crowd management as a matter of course.

b) The prevention of crime and disorder

See c) below for event stewarding. We use a local firm to patrol the ground on at least two occasions every night to prevent crime and disorder from occurring on the premises in addition to our own staff checking the ground each night. Safety lighting is provided around the ground to minimize blind spots and encourage safe use of the premises

c) Public safety

Experienced qualified stewards are used on all relevant event days supervised in line with current guidelines. The premises are subject to an annual safety advisory group review with special attention to regulated stands. The club employs an experienced and well respected local safety officer with whom it consults prior to all major events. The ground is maintained to a high standard with special attention to the needs of its mixed audience. For any concert event we would require the promoter to provide specialist experienced stewarding for crowds using our own for car parking and hospitality stewarding only. A number of full time staff have been trained as fire Marshalls to support and advise on events days.

d) The prevention of public nuisance

Advise all patrons through signage and verbally to minimize any disturbance to neighbours when arriving and leaving the premises. All staff are told to respect neighbours when working evening shifts and avoid making unnecessary noise. On major event days additional parking is identified and visitors advised of its availability through notice and AA road signs to minimise the impact on local parking. Floodlight use (at full power) is restricted to 2215pm at the latest for a maximum of 15 occasions per annum.

e) The protection of children from harm

All Stewards are trained by the safety officer in how to ensure that children attending matches are not exposed to harm. Parents are encouraged to attend events with young children through offers. Risk assessments have been carried out throughout the premises where risks have been identified. There are no gaming machines on the premises


