Please take this letter as an objection for Mr Mehmet Demen Bayram, Bestone, to be granted a premises licence, under Protection of Children from Harm, Prevention of crime and disorder, Public Safety, Prevention of public nuisance.

Prevention of public nuisance

We have had many problems within this area. There were many drunks who urinate in the alley ways and intimidated the public while we walked along the Weedon Road. Even along my street they used to sit and drink. However, even though these problems have been reduced, we still do have problems with drunks along with cars & delivery vans which use these premises blocking the bus stop.

Protection of Children from Harm

Previously, St James has suffered with gangs of children fighting and drinking next door to the applicant's premises. With different off-licences, we suffered. With both owners who were not related nor knew each other, sold alcohol to children, drunks and anyone who was intoxicated, within a few years. These children, were drunk at all times of the day, and used to throw their glasses/cans on the parade along. I have grandkids that could not even go to the fish & chip shop. Why should we have all this returning?

Prevention of crime and disorder

The crime & disorder was horrid a few years ago. The bus stop smashed up, phone box vandalised every other day, cars damaged, and houses. There was also on occasions where passing cars & buses were targeted. If they are granted a licence, they could congregate behind the shops alley way and drink along Bruce Street as they have done previously.

Public Safety

This is my main concern, as there is still a problem. The general public have been attacked by the gangs of children. They would push over & on occasions beat up any members of public. I have witnessed this when they pushed over a member of the public while she was with her children. The customers of Beacon Bingo have also been

targeted. A couple of weeks ago, there were groups of children who were shouting, and drinking under the Beacon Bingo car park and the steps up to the entrance. The area is still not without problems and they can only get worse if another premises opens. The Indian restaurant has had customers beaten up as they have been trying to get into the restaurant and I know that the manager of Rainbow Fish shop was attacked and had to be taken to hospital.

I believe there is enough justification as to why not to grant this application a premises licence.

PLEASE DO NOT GRANT A PREMISES LICENCE...PLEASE!



I have been victimised and so has my girlfriend when we used to visit the take-away's along the Weedon Road. I do not think I want the times where I have had bottles thrown us nor have abuse shouted at me or being spat on again. This was not just on one occasion but on my times. On many occasions I saw them hiding around the corners and in the back roads to the shops, drinking and doing other anti social things. In my opinion, this will return in one way or another. If this does, then other children will then try to fall into this crowd and start drinking. There are certain psychological influences with children's group and would encourage them to "follow the crowd". This would lead to physical confrontation between the kids or other rival gangs as has happened many times before.

We still have the odd group of kids but not close to the state we have had. We had some issues recently were one evening were around 50 or more children had been drinking and were on my street fighting. The police were called on 2 occasions that evening. They then ran across the road into a neighbouring housing estate throwing bottles and carried on fighting there. The next morning our street and the bushes were full of rubbish including broken bottles of Vodka.

The residents then had to clear this up in case. Things like this will only escalate of another off-licence opens up.

The extra noise along with people who may use the shop will also cause extra traffic into the area, which if you ask any resident who lives here, is causing more and more aggravation every day.

With all of these factors taken into consideration I believe you will agree it is <u>not</u> in the best interests for the local community to grant this application.

I would like to object to the above premises licence application. I object under all four of the licensing objectives. My reasons are listed below.

The prevention of Crime and Disorder

We have had 2 previous "attempts" at opening off-licences along the parade of Weedon Road. Both were closed down for selling under-age alcohol amongst other items. However the underage selling of alcohol was not the only problem. While both independent off-licences were open, there were many problems with children and drunks causing damage to public property on the Weedon road such as the bus stop and the telephone box. They also used to get extremely drunk and fight on the streets around the Weedon road and I have also witnessed them fight with members of the public. Damage to residents was also common while the off-licences were open.

Public Safety

I believe that not only will the safety of residents but he safety of the general public will be at risk. From past experiences, I seen members of the public attacked while walking along the Weedon Road. The business on the Weedon Road have also suffered. The China Cottage manager was attacked for no reason by drunk children who were using the alley way as a place to drink. The Rainbow fish and chip shop manager was also beaten up by the gangs of children that congregated outside his shop.

The prevention of Public Nuisance

There was always broken glass and cans outside the shops and around the side streets. Litter as a big problem as children and drunks used to drink on a daily basis and always left their rubbish on the floor. In the mornings it would blow all along the Weedon road. I along with other residents always used to pick this up. I also know that a residents pet dog was hurt when it had glass got into its paw. There used to be a lot of noise from people either leaving or enter the premises. We used to get them shouting at all time of the day and night while walking down past our house or while they congregated around the side streets. The parking

is also a big concern. They park in front of the shop and buses have to either drive past leaving people stuck at the bus stop. Granting this licence will only worsen this problem.

The protection of Children from Harm

This is most important objective of all. I have seen large gangs of children (all under the age of 18) walking into the previous off-licences at 89 Weedon Road and purchase alcohol. This would lead to them drinking on the streets and then seem to either fight with each other or members of the public. The resident's children and families were also subject to harassment as they walked past the shops. If the off-licences were not given a premises licence before then a lot of the children would not have suffered.

In summary, The Weedon Road and surround streets are very clean and safe. This was not the case before. When the previous off-licences of Snow White and Rice's Wines opened a lot of these problems started. We did not have any of the underage drinking, the litter, the drunks loitering. The ASBO. But as soon as the last off-license closed (Rice's Wines), all the problems seemed to magically disappear overnight. There is hardly any trouble and we again feel that with the opening of another off-licence, the area will be brought back to the way it was and could handle another premises selling alcohol to open. On this basis, Please place my objection forward **NOT** to grant a premise licence at 85-87 Weedon Road.



The owner would not have any control of things outside his shop and nothing would be done about things, we have had ASBO's against the kids which was great.

PROTECTION OF CHILDREN FROM HARM

Selling of alcohol to under age kids leading to binge drinking.

Kids causing harm to themselves and people in the area.

Children within the area going to the shops being harassed, attacked or injured.

PREVENTION OF CRIME & DISORDER

Kids or people under the influence of alcohol, we get a lot of crime within the area. Gangs of kids lurking around causing disruption and harassing the residents. My husband was attacked coming out of the paper-shop after buying a can of coke which led to my husband chasing after one of the youths, if he had caught him he would probably have been arrested due to his actions.

PUBLIC SAFETY

No one is safe within the area as we have gangs of kids hanging about because they know they will be served with alcohol.

People not being able to get past due to bikes all over the paths.

Old people not coming out of there houses for fear of being harassed, and this is probably the only contact they have with the outside world.

PREVENTION OF PUBLIC NUISANCE

Don't give them a licence as we already have one shop in the area which sells alcohol but to adults only resulting in no kids under age being drunk and disorderly and causing a nuisance to themselves and the public.

I would like to object to the granting of the above as due to previous experience of other like premises in the area which would not fulfil the licensing objectives:

- Protection of Children from Harm
- · Prevention of Crime and Disorder
- · Public Safety
- Prevention of Public Nuisance

Whilst 'Snow White' and 'Rice Wines' were trading with Off Licenses during 2005 to 2006 the area became inundated with young people, loitering whilst intoxicated, which was a huge problem for local residents and businesses. It particularly affected our business as the young people would congregate around our premises entrance and car park, accosting and abusing our customers, a majority of which are elderly and who felt particularly threatened and intimidated. The problem was so bad that a "Dispersal Order" was put in place in the local area in conjunction with local residents and businesses including the Northampton Saints Rugby Club.

During the time "Best One" has been open I have personally witnessed a fight outside the premises and there has already been a noticeable increase in disorderliness among young people in the general area

The problems we encountered before and currently certainly did not and do not fulfil any of the current Licensing Objectives and I hope that you will take this into consideration when considering the above application

RE: Licensing Act 2003 – Premises Licence Application 85-87 Weedon Road, St. James, Northampton NN5 5BG

I can confirm that we have been instructed to represent KP News & Off licence in respect of the above application.

Having considered the application, we are concerned that if this were granted then there would be a significant impact upon the licensing objectives of prevention of crime and disorder, protection of children from harm and public nuisance.

The area surrounding the premises has been noted over time as having a significant crime rate and it is expected that the police will provide statistics on this aspect. Our clients have witnessed various crimes in the area and have been party to evidence that has been given by others of particular problems, including assaults. It is believed that some of this crime is fuelled by the consumption of alcohol and great care therefore needs to be exercised in sales. The application fails to recognise the existence of other premises within the area that are licensed for the sale of alcohol and the additional impact that another premises will have. In particular, it fails to recognise or address the issue of 'pre-loading'.

It is noted that the applicant proposes to undertake a number of measures in order to prevent under age sales, but these proposals are badly worded and if translated directly into conditions they would be of little use as there would be severe difficulty in enforcing them. At best, the conditions are vague and not of the standard that would be expected for an application of this type.

Whilst the applicant proposes to erect signs and ask all customers to leave quietly, the application does not propose any measures that would impose a sanction if customers decided to ignore the request. It is suggested that simply to post notices would be insufficient to have the desired affect.

Our clients respectfully ask that the application be refused on the grounds that the applicant has not sufficiently demonstrated a commitment to promoting the licensing objectives. The conditions offered are vague, unenforceable and do not go far enough bearing in mind the history of the area and the significant risks involved.

We confirm that we have been asked to represent our clients at any hearing and we may wish to amplify or extend the reasons for making a representation at that time.



I am writing to express my concerns regarding the application by Mr Mehmet Demen Bayram for a premises License at Best-One on Weedon Road, St James.

The main concern is regarding the potential return of anti-social behaviour to the immediate area surrounding the store and the consequent public nuisance and possible crime, disorder and public safety issues.

Up until relatively recently the area surrounding Franklin's Gardens – including the shops over the road from the stadium – were subject to an Anti-Social Behaviour Order. Although that order has now passed there is still a significantly lower amount of disorder than there was prior to the order coming into force.

As well as the ASBO I believe that this is due to the responsible attitude towards the sale of alcohol and restricted hours in which alcohol has been sold in the area immediately around Franklin's Gardens.

I have concerns that a premises License, if awarded to Best-One, would see a potential return to the issues seen in the past.
