All figures given below, are the movement in the last eleven months.

- Overall debt levels as at 31st July 2012
Unmanaged debt is £479.9k less and the overall outstanding arrears are a £2.732.7m increase, however these figures now include the whole outstanding balance on the Agresso system (Sundry Debt), not just the cases that are in recovery. In real terms this is a £505.7k decrease in the value of cases in recovery.
- Council Tax as at 31st July 2012
Unmanaged debt is £235k less and the overall outstanding arrears are £1,206.9k less.
- Business Rates as at 31st July 2012
Unmanaged debt remains unchanged. The overall outstanding arrears are £5.9k less.
- Former Tenant Arrears as at 31st July 2012
Unmanaged debt is £129.6k less and the overall outstanding arrears are £323.6 less.
- Housing Benefit Overpayments Payments as at 31st July 2012
Unmanaged debt is £101.4k more, primarily due to the increase in cases requiring court action, over one month old and cases awaiting review following return by the debt collection agents. The overall outstanding arrears are £240.8k less.
- Sundry Debts as at 31st July 2012
Unmanaged debt is £216k less, although the overall outstanding balance is £4,329.9k more. See above notes.
- Priority Debts 31st July 2012
As a result of priority debt as defined by the Corporate Debt Policy we now have debt on hold awaiting clearance of priority debts. This is broadly broken down as FTA £105k as at 31st July, Sundry debt £24k and OPHB £127k. As more cases reach consideration for court action this category of debt pending other priority debt will increase.
