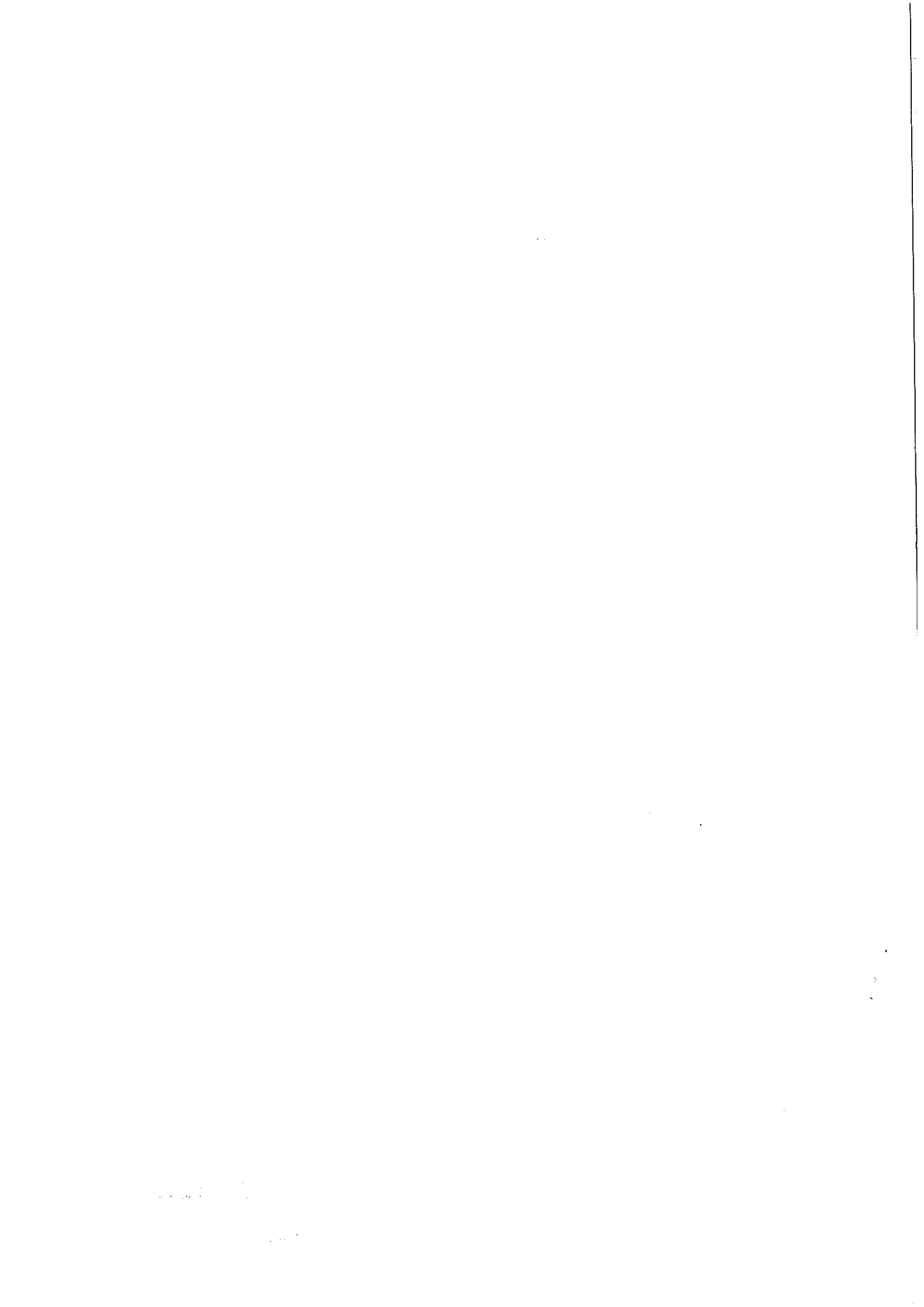

The application seeks to make two changes to the licence;

Firstly, to alter the layout of the premises in accordance with the plans deposited with the application;

Changes to the ground floor are minor and involve alterations to the style of some of the seating. Plan no. 1239.1 shows the existing layout and 1239.2 shows the proposed.

Changes to the first floor involve the development of an external terrace. Plan no. 1239.03A shows the existing layout and 1239.004A shows the proposed. A "Roof Terrace Policy" is enclosed with the application.

Secondly, to amend Condition B(2) of Annex 1 regarding glassware so that it reads "Toughened glassware shall be used where available."

There are to be no other changes to the licence – the hours of operation and types of licensable activities are to remain the same.

The works are scheduled to commence in May / June 2013. We therefore request that the variation does not take effect until the works have been completed.

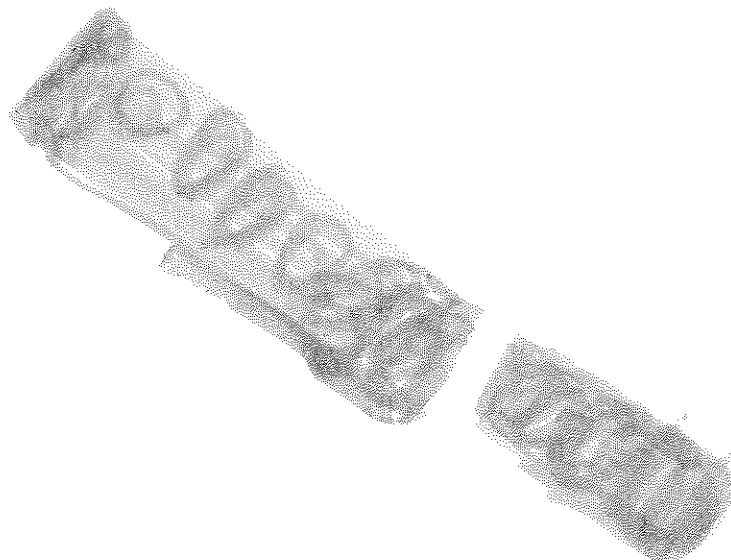
