8 November 2004 – Smoke Free Northampton	
Councillor Allen moved and Councillor Church seconded:- "This Council notes the results of the East Midlands Big Smoke Debate" involving 24,145 respondents. 88% of those respondents said they would prefer indoor public places to be smoke free.	On 1 December 2004 Northampton Borough Council and Northampton Primary Care Trust became the first signatories to the new Smoke-Free Northampton Charter. The Charter sets out how the partners will help to protect public places and workplaces.
The Council welcomes the decision of Liverpool City Council to seek the early introduction of a ban on smoking in public places in Liverpool through a private bill in Parliament. Following some debate on the motion Councillor J Lill moved and Councillor Tavener seconded an amendment which deleted the second paragraph regarding Liverpool City Council and the final paragraph commencing "This Council supports legislation" and insert instead:

"This Council resolves to work with our partners to encourage local businesses to introduce a voluntary ban on smoking in indoor work places.

The Council resolves to work with the Primary Care Trust and the Smoke Free Northants Alliance to support smokers who want to quit and particularly to act as an example of an employer who has introduced smoke free policies into its work places.

The Council endorses the support proposed by the Executive to the Smoke Free Northampton Working Group in order to allow the full implications of the approach to be assessed.

The amendment was duly debated voted upon and lost.

The original motion was then voted upon and carried.

8 November 2004 - Northampton Citizen Awards

Councillor Glynane then moved and Councillor Church seconded:- "This Council wishes to recognise Northampton's Citizens who have served this town over many years helping others making a difference in their communities or contributing to the overall development of Northampton.

This Council requests the Executive, in consultation with the Mayor and the party leaders, to prepare a plan to recognise such citizens at an annual event where their outstanding contribution can be formally recognised and celebrated".

Councillor Miah then moved an amendment to the motion which was seconded by Councillor Lane:- This Council wishes to recognise the contributions of people who live and work in Northampton helping to make a sufficient difference in their communities as well as helping others and contributing to the wellbeing and development of our town.

This Council wishes to build on current events which recognise outstanding contributions in the town and seeks the support of the whole Council including the Mayor in organising an annual event that will be the highlight of our civic calendar.

This Council seeks the support of the Forums, Residents Associations, Area Partnerships and Local media and businesses including the Northampton Celebrate and Town Centre Partnership in seeking nominations and sponsorships for this flag ship event to reward achievements in a wide range of areas."

- Councillor Miah, along with two other Councillors are currently developing this concept via Scrutiny. The aim of the working party is to scope out options, visit other local authorities who operate such a scheme, involve two members of the youth forums and offer information to the Executive to inform their deliberations.
- 2. This will continue to be developed in accordance with the motion.

8 October 2004 - Closure of Radlands Skateboard Facility

Councillor Glynane then moved and Councillor Church seconded a motion of regret:

"That this council regrets the news that Radlands is due to close on 10 October. This council recognises that Radlands provides a unique indoor facility for Northampton, and resolves to work with users to find a way of maintaining an indoor skateboard and BMX facility in Northampton. This Council requests the Executive:

- 1. To explore all options to ensure that the facility continues to be provided
- 2. Work with users to ensure that they are consulted and involved in those options
- 3. Work with other local bodies providing leisure facilities for young people
- 4. Work with Northampton Co-operative Development Agency to consider a users co-operative Development Association to consider a users co-operative venture"

The motion was duly debated, voted upon and carried unanimously.

1. There has been a significant set back in that Groses have moved to clear and release the building. Any replacement skateboard facility will now need to be in new premises with completely new ramps and facilities. Consequently, it is necessary to re-evaluate the feasibility of proceedings.

8 October 2004 - Work of the Youth Forum

"That this Council welcomes the 'Making your Mark' focus of local democracy week (18-24) October this year in a background of reducing percentages of young people voting. This Council believes that the young people of this town are one of the most valuable resources in the community. This Council believes it essential to engage young people to be a recovering and effective authority. This Council believes that to do this we need to:

- Steve Pointer met with Professor Hugh Matthews on 27

 in his proposals on how UCN might be able to help research
 youth needs and consult with young people. This matter was
 reported to the local LSP who are going to consider the matter

- 2. The work will enable the Northampton Vision to be developed

- > Ensure that work of the Youth Forum be developed
- Encourage young people to play an active part in their forthcoming conference given the focus on Northampton's future
- Consult with young people to seek the views of young people on lowering the voting age to 16"

Councillor Glynane then moved and Councillor Simpson seconded an amendment to the motion with the following addition:

"That the Council seeks to engage more with sixth formers, college students and those young people not at school by seeking the creation of additional forums and through promoting the establishment of a local youth parliament linked to the National Youth Parliament"

The amendment was duly debated, voted upon and carried to become the substantive motion.

8 October 2004 - Illegal Traveller Encampments

"This Council condemns the amount of illegal traveller encampments which have increased over the last twelve months. The comments of the Leader of the Council who heaps the blame on the County Traveller Unit are unproductive, when many of his Conservative colleagues in other District Authorities have signed up to the Unit and are working effectively. His party's claim to a zero tolerance policy is now in tatters. We call on the Executive of this Council to develop a policy, which is achievable. This policy should clearly show approaches in the long, medium and short term and be presented at the first full Council of 2005"

Councillor Glynane then moved and Councillor Church

"Every local housing authority must, when undertaking a review of housing needs in their district under section 8 of the Housing Act 1985 (c. 68), carry out an assessment of the accommodation needs of gypsies and travellers residing in or resorting to their seconded an amendment to the motion with the following addition:

"This Council endorses the following House of Commons Early Day Motion No 79 on traveller accommodation sponsored by Labour MP Kevin McNamara and signed by 117 Mps of all three main parties"

"That this House is deeply concerned that the shortfall of traveller sites is causing severe hardship for the gypsy and traveller community and is leading to a deterioration in relations between the traveller and settled community: notes that the Institute for Public Policy Research has produced proposals for traveller sites entitled "Moving On" which has received widespread support, further notes at the ODPM Select Committee Report on the draft Housing Bill has called upon the Government to introduce a statutory duty on local authorities to provide and facilitate gypsy and traveller sites; calls upon the Government to ensure that mechanisms are urgently put in place to provide and facilitate a sufficient number of travellers sites; and further note such action is supported by the Institute for Public Policy Research, Local Government Association, Shelter, Children's Society, Traveller Law Reform Coalition and Commission for Racial Equality.

This Council requests the Acting Chief Executive to write to our MPs urging them to support this motion and to Kevin McNamara MP and the relevant Government Minister informing them of this Council's support for the early day motion.

This Council requests the Executive to work with the other Councils in the County Traveller Unit in order to provide and facilitate suitable traveller sites in the County to which unauthorised traveller encampments can be directed"

Subsection (3) applies where a local housing authority are required under section 87 of the Local Government Act 2003 (c. 26) to prepare a strategy in respect of the meeting of such accommodation needs.
