

# VARIATION OF PREMISES LICENCE APPLICATION Licensing Sub-Committee Wednesday 15 August 2018

### 1.0 Purpose of Report

1.1 To consider an application for the variation of the premises licence for The Turkish Social Club, 4 Henry Street, Northampton NN1 4JE.

### 2.0 Summary

2.1 An application for the variation of a premises licence was submitted on behalf of The Turkish Social Club by Mr John Birch as an agent on behalf of Cahit Menekse who is the Designated Premises Supervisor under the licence. The application was received by Northampton Borough Council on the 3 July 2018. A premises licence was originally granted to the Turkish Social Club on 8 April 2014 under licence number PL1035. (Appendix A).

### 3.0 Application Details

- 3.1 The variation application was submitted with the intention to extend the single storey ground floor to the rear of the existing to provide an additional area for licensable activities. The variation plan also includes an outside smoking area for consumption of alcohol and use of a previously disused basement for pool and similar activities. A copy of the application is attached as Appendix B and plan Appendix C.
- 3.2 The licensable activities and times granted for the original premises licence on 8 April 2014 are for the following;

### Sales of Alcohol for consumption On the premises:

Monday - Sunday 10:00 - 02:00

Late Night refreshment:

Monday - Sunday 23:00- 02:00

### 4.0 Consultations/Representations

4.1 When a request for the variation of a premises licence or club premises certificate is received, the applicant must display a notice at or near the

premises and serve a copy of the application onto the responsible authorities. For electronic applications it is a requirement of the local authority to serve a copy of the application onto the responsible authorities.

This gives responsible authorities and interested parties the opportunity to make representations in relation to the application for a period of 28 calendar days. The last date for representation was the 31 July 2018.

- 4.2 The obligatory notice was displayed on the premises as verified by licensing officers on the 14 July 2018 and in a local newspaper on the 12 July 2018. A copy of the notice is attached as Appendix D
- 4.3 The Licensing Department has received one relevant representation under the licensing objective of prevention of public nuisance from a local resident. A copy of the representation is attached as Appendix E
- 4.4. The Licensing Department has also received a representation from Environmental Health under the licensing objective of prevention of public nuisance. This representation has since been withdrawn following agreement between the applicant and the representor to end licensable activities in outside areas at 11.00pm on Mondays to Saturdays and 10.00pm on Sundays and Bank Holidays. A copy of the representation and subsequent agreement are attached as Appendix F.
- 4.4. The Planning Department responded to the application clarifying that the premises would require planning permission, however although an application had been submitted the outcome is still pending. A copy of the correspondence received as attached as Appendix G.
- 4.4 Northamptonshire Police have considered the application and have made no representations.

### 5.0 Attendance

5.1 The local authority is required to send a notice of hearing to all interested parties and request confirmation of attendance. A notice of hearing was sent to the following persons on 3 August 2018.

John Birch on behalf of The Turkish Social Club – confirmation of attendance received.

### 6.0 Plan of Premises Layout & Location

### 7.0 Options

- 7.1 At the end of the consultation period the licensing authority must hold a hearing. It must take such steps as it considers appropriate for the promotion of the licensing objectives, which are:
  - the prevention of crime and disorder
  - public safety
  - the prevention of public nuisance
  - the protection of children from harm

The steps the Sub-Committee can take are to:

- reject the whole or part of the application;
- To modify the conditions of the licence (excluding the mandatory conditions).
- 7.2 The Sub-Committee should note that, although the applicant has stated that they agree to the conditions referred to at paragraph 4.4 above, it is for the Licensing Sub-Committee to determine what conditions are added to the licence.

### 9.0 Committee

Each application must be considered on its own merits and any conditions attached to licences and certificates must be tailored to the individual style and characteristics of the premises and events concerned. This is essential to avoid the imposition of disproportionate and overly burdensome conditions on premises where there is no need for such conditions. Standardised conditions should be avoided and indeed, may be unlawful where they cannot be shown to be appropriate for the promotion of the licensing objectives in any individual case.

The following mandatory conditions are to be applied to the licence stated above in accordance with section 3 (1) of The Licensing Act 2003 (Mandatory Licensing Conditions) Order 2010.

### The following conditions shall come into force on 6th April 2010

- (1) The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carrries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children-
- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-
- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the perod in which the responsible person is authorised to sell or supply alcohol), or
  - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in secitor 159 of the Act:
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the pruchase and consumption of alcohol over a period of 24 hours or less:
- (d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on-
  - (i) the outcome of a race, competition or other event or process, or(ii) the likelihood of anything occurring or not occurring;
  - (e) selling or supplying alcohol in association with promotional posters or flyers on, or in

the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner

- 2. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 3. The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.

The following mandatory conditions are to be applied to the licence stated above in accordance with section 3 (1) of The Licensing Act 2003 (Mandatory Licensing Conditions) Order 2010.

### The following conditions shall come into force on 1st October 2010

- (1) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
- (2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark
- 5. The responsible person shall ensure that-
- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having ben made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-
  - (i) beer or cider: 1/2 pint;
  - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
  - (iii) still wine in a glass: 125 ml; and
  - (b) customers are made aware of the availability of these measures.

### ANNEX 1 - MANDATORY CONDITIONS

### Mandatory conditions where licence authorises supply of alcohol

- (1) No supply of alcohol may be made under the premises licence -
  - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
  - (b) at a time when the designated premises supervisor does not hold a personal

- Plays: no licence is required for performances between 08:00 and 23.00 on any day, provided that the audience
  does not exceed 500.
- Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
- Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided
  that the audience does not exceed 1000.
- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman
  wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not
  exceed 1000. Combined fighting sports defined as a contest, exhibition or display which combines boxing or
  wrestling with one or more martial arts are licensable as a boxing or wrestling entertainment rather than an
  indoor sporting event.
- Live music: no licence permission is required for:





We are writing to you to register our objection to the Variation Application 057376 by 4 Henry Street Northampton. The basis for this opposition is that granting the variation to the license for these premises will not promote the licensing objectives, particularly the prevention of public nuisance.

We live a block of terraced houses.

Our biggest concern with regards to the Variation Application is the noise levels. On quite a number of occasions we have posted polite notices through the door to ask them to keep the noise down which they have blatantly ignore. We both work 9-5 jobs and as you can imagine trying to get to sleep with the noise they are making is already difficult, our concerns are that this extension is going to cause more disruption and I fear this will start to affect our work. We feel that they are not respectful to us and other members of the street when they are banging doors, shouting and generally just causing a nuisance to us

Another concern we have is the litter and smoking, we are at a point where we have had to close our Living room window because people loiter outside the front of the house smoking, when we have asked them to move they have just ignored us. On a weekly basis we have to sweep outside our house because people have littered outside our window and I have watched them first hand go back into 4 Henry Street, our bin day is a Monday and there is always rubbish outside the property before this, as you can imagine in the summer especially, it is not nice, we cannot have our Living Room window open because of the odour of rubbish and smoke.

Parking is another issue, as I am sure you are fully aware we live on a terraced street where parking is limited anyway, with this Variation Application we feel this is going to cause us an even bigger problem. Why should we not be able to park outside of our house in a residential street because of the business next door?

In view of the above, I would urge the Licensing Authority to refuse the application.
