

#### **REVIEW OF PREMISES LICENCE –**

# Alcohol & Gambling Licensing Sub-Committee Wednesday 30 May 2019

#### 1.0 Purpose of Report

- 1.1 To consider a request from Northamptonshire Police for the Review of the Premises Licences for the following premises:
- 1.2. Europe Supermarket, 102A Abington Street, Northampton;
- 1.3. Europe Supermarket 340-344 Wellingborough Road, Northampton; and,
- 1.4. Aryan Coffee 166-168 Lutterworth Road, Northampton.

#### 2.0 Summary

- 2.1 The review applications were received on the 11 February 2019 and submitted in accordance with licensing objective(s) for:
  - The Prevention of Crime and Disorder; and
  - Public Safety

Copies of the applications for each premises are attached (Appendices A, B and C).

2.2 The current licence holder for each of these licences is Sarbaz Amin Abdullah. The premises licence for Europe Supermarket 102A Abington Street is recorded as PL1139 (Appendix D). The premises licence for Europe Supermarket 340-344 Wellingborough Road is recorded as PL1053 (Appendix E) and the premises licence for Aryan Coffee is recorded as PL1144 (Appendix F).

#### 3.0 Consultations/Representations

- 3.1 When a request for the review of a premises licence or club premises certificate is received, the licensing authority must display a notice at or near the premises, and on the council's website. This gives responsible authorities and any other interested parties a 28 day period for the opportunity to make representations in relation to the review application. It is the responsibility of the applicant to serve a copy of the review application onto the licence holder and the responsible authorities.
- 3.2 The local authority displayed the obligatory notice on each of the premises on the 11 February 2019. (Appendices G, H and I).
- 3.3 During the 28 day period no representations have been received.

- 4.2 On 15 March 2019 a letter was received from Woods Whur Solicitors confirming their appointment to represent the Premises Licence Holder Mr Abdullah. The letter requested that, in view of the serious allegations raised in the Review, the Committee adjourn the hearing date to give sufficient time to take instructions from their client (Appendix J). In consultation with the Chair of the Alcohol and Gambling Licensing Committee it was agreed that the time period for holding the hearing of the Review application would be extended in accordance with the Licensing Act 2003 (Hearings) Regulations 2005.
- 4.3 In addition to confirming his attendance, PC Stevens has provided copies of a number of documents which are relevant to the application for review. Copies are attached (Appendix K).

### 6.0 History of Premises & Licence Holder

- 6.1 Mr Sarbaz Amin Abdullah became the licence holder of Europe Supermarket PL1139 on the 14 September 2017 and the Designated Premises Supervisor (DPS) on the same date.
- 6.2 Mr Abdullah became the licence holder of Europe Supermarket PL1053 on 20 October 2015 and DPS on the same date. On 17 December 2015 a Review of the Premises licence was requested by Northamptonshire Police under the licensing objectives for
  - The prevention of crime and disorder; and,

The protection of children from harm.

As a result a Licensing Committee hearing took place on 10 February 2016 to consider the application, the Notice of Determination following that hearing is attached (Appendix L).

- 6.3 Mr Abdullah became the licence holder for Aryan Coffee PL1144 on 2 November 2017 and DPS on the same date. On 10 October 2017 following the application for a new grant for these premises, a representation was received from a local resident under the licensing objective-
  - · The prevention of public nuisance.

As a result a Licensing Committee hearing took place on 27 November 2017, the Notice of Determination following that hearing is attached (Appendix M).

#### 7.0 Options

- 7.1 At the end of the consultation period the licensing authority must hold a hearing. It must take such steps as it considers appropriate for the promotion of the licensing objectives, which are:
  - · the prevention of crime and disorder;
  - · public safety;
  - the prevention of public nuisance; and,
  - the protection of children from harm.

The steps the Sub-Committee can take are to:

- · modify the conditions of the licence;
- exclude a licensable activity from the licence;
- · remove the designated premises supervisor;
- suspend the licence for a period not exceeding 3 months; and/or,
- · revoke the licence.
- 7.2 For the purpose of a) above, the conditions are modified if any of them are altered or omitted or a new condition is added. Further, if the Sub-committee takes either of the steps at a) or b) above it may provide that the step only has effect for a limited period (of up to 3 months).

#### 8.0 Policy Considerations

8.1 Northampton Borough Council Statement of Licensing Policy;Sections 18 and 19 give guidance in relation to this application.

#### 8.2 s.182 Guidance Licensing Act 2003;

Section 11 gives guidance for determination of this application.

Subsections 11.16 to 11.28 highlight the elements of the Guidance that are most relevant with respect to this application. This is not exhaustive and the guidance should be considered fully prior to making decisions with respect to applications.

#### 9.0 Committee

Each application must be considered on its own merits and any conditions attached to licences and certificates must be tailored to the individual style and characteristics of the premises and events concerned. This is essential to avoid the imposition of disproportionate and overly burdensome conditions on premises where there is no need for such conditions. Standardised conditions should be avoided and indeed, may be unlawful where they cannot be shown to be necessary for the promotion of the licensing objectives in any individual case. Any action taken in relation to the application should be appropriate for the promotion of the licensing objectives and proportionate to the problems giving rise to the review.

On the 22nd August 2018, HMRC also executed warrants at four premises including the home address of Color During this search, a vehicle associated with him was searched and evidence relating to the distribution of tobacco was discovered.

A search of Europe Supermarket Wellingborough Road also resulted in the sefzure of in cash in carrier bags and a small safe.

A search of a business unit in Color associated with the Organised Crime Group resulted in the seizure of 2.4million non-duty paid cigarettes with a revenue evasion value of Color and previously been observed at the business park and HMRC believe that this was to arrange the lease of the unit.

Based on this information, the Police believe that Europe Supermarket on Wellingborough Road is a base for Organised Crime and is heavily linked to the sale and storage of illicit tobacco.

The nature and scale of the offences suspected of being committed in this case lead the Police to the conclusion that on the balance of probability, the oriminal earnings of this OCG have been used to set up and run the business of Europe Supermarket on Abington Street. Further there are reasonable grounds to believe that the accounts of this premises are being used to launder this money in such a way as to make it appear legitimate. Given these conclusions, the Police are asking the Licensing Committee to revoke this premises licence.

The review is being applied for due to the ongoing criminal investigation into the illegal activities of the Licence Holder The background to the is suspected to be central to an Organsised invesitgation is that Crime Group (OCG) that imports and sells a substantial amount of non-duty paid and counterfeit cigarettes and tobacco. The criminal investigation was started and has been conducted by Her Maiesty's **The** Revenue and Customs (HMRC) under an operation called focus of this operation has been as well as has admitted working for and Over the course of a two year period, HMRC have conducted disruption work against this OCG and this has led to sizeable cash and tobacco selzures from various places around the UK including in Northampton. These seizures have been linked to members of One of the most significant of these seizures took place on the 14th August 2018 when officers from HMRC visied Europe Supermarket on Wellingborough Road to conduct an inspection visit. During this visit, a van connected to the premises was forcibly entered and searched which resulted in the selzure of 23,980 clgarettes and 2.4kg of tobacco from the rear of the vehicle in amongst boxes that bore the Europe

Supermarket branding.

On the 22nd August 2018, HMRC also executed warrants at four premises including the home address of During this search, a vehicle associated with him was searched and evidence relating to the distribution of tobacco was discovered.

A search of Europe Supermarket Wellingborough Road also resulted in the seizure of in cash in carrier bags and a small safe

A search of a business unit in associated with the Organised Crime Group resulted in the seizure of 2.4million non-duty paid cigarettes with a revenue evasion value of the seizure of the part and HMRC believe that this was to arrange the lease of the unit.

Based on this information, the Police believe that Europe Supermarket on Wellingborough Road is a base for Organised Crime and is heavily linked to the sale and storage of illicit tobacco.

The nature and scale of the offences suspected of being committed in this case lead the Police to the conclusion that on the balance of probability, the criminal earnings of this OCG have been used to set up and run the business of Europe Supermarket on Abington Street. Further there are reasonable grounds to believe that the accounts of this premises are being used to launder this money in such a way as to make it appear legitimate. Given these conclusions, the Police are asking the Licensing Committee to revoke this premises licence.

#### **Licence Conditions**

#### **CCTV**

A fully working and maintained system capable of recording and storing images must be installed on the premises. The system must record at all times the premises is open to the public and images must be stored for a minimum of 28 days with date & time stamping. As a minimum this must cover all entry and exit points, both sides of all areas where the sale/supply of alcohol takes place.

All recordings must be made available to an officer from a responsible authority upon reasonable request and in line with the provisions of the Data Protection Act 1998.

#### **Staff Training**

All staff involved in the retail of alcohol will be trained in relation to the law regarding its sale. This training must be completed prior to them being authorised to sell alcohol and refreshed every 12 months as a minimum. A record of this training must be kept and maintained with a copy of the syllabus attached. The recipient of the training must sign to state that they have received and understood the training and this should be dated. Training records must be kept on the premises at all times and made available to an officer from a responsible authority upon reasonable request.

#### Nuisance

Signs will be displayed at the exit points of the venue requesting that customers respect local residents by leaving and dispersing from the premises and immediate area quietly and in an orderly manner. Staff will take all practical steps themselves and work with Northamptonshire Police and Northampton Borough Council in deterring groups of people from gathering in the immediate area outside the premises and causing harassment, alarm or distress.

#### Age Verification

The premises will operate and adhere to an age verification scheme with the minimum standard of Challenge 25. Signs advertising the policy must be displayed in all areas where alcohol is for

A refusals register will be kept on the premises for the recording of any incidents involving the refusal of a sale of alcohol due to age or drunkenness. The register will be made available to an officer from the local authority for inspection upon reasonable request

#### Miscellaneous

Spirits must be displayed behind the sales point and will not be available for self-service.

There will be no sales of beer lager, or cider over 6% ABV.





All staff employed where alcohol is retailed must undertake training on responsible alcohol retailing and the law with respect to alcohol sales. This will include instruction in relation to a suitable age verification challenge 25 policy. Training must be completed prior to the commencement of employment on the premises and refresher training must be completed every six months as a minimum. This training must be documented (syllabus, who delivered it, when and where) auditable and signed for by the recipient of the training. The training records must be made available for examination upon reasonable request by a police officer or authorised officer.

The recordings shall be kept for no less than 31 days.

There shall at all times when the premises is open to the public but not authorised for alcohol sales, a means of covering up the alcohol in the public areas. There shall also be signs attached to the covering stating that alcohol is not available for sale.

There shall be signs by each point of sales reminding staff of the licensable hours of the premises.

A refusals register be in the format of a hard backed, page paginated book and be provided to the police and licensing authority upon request



The following mandatory conditions are to be applied to the licence stated above in accordance with The Licensing Act 2003 (Mandatory Licensing Conditions) Order 2010 as amended by the The Licensing Act 2003 (Mandatory Licensing Conditions)(Amendment) Order 2014.

### The following conditions shall come into force on 1st October 2014

- 1. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises-
- (a)games or other activities which require or encourage, or are designed to require or encourage, individuals to-
- (i)drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
- (ii)drink as much alcohol as possible (whether within a time limit or otherwise);
- (b)provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c)provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d)selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e)dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

- 2. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 3. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol
- (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either-
- (a)a holographic mark, or

(b)an ultraviolet feature.

4. The responsible person must ensure that-

(a)where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-

(i)beer or cider: 1/2 pint;

(ii)gin, rum, vodka or whisky: 25 ml or 35 ml; and

(iii)still wine in a glass: 125 ml;

(b)these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and

(c)where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available."

  - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979
  - (b) "permitted price" is the price found by applying the formula-

$$P = D + (DxV)$$

- (i) P is the permitted price,
- (ii) D is the rate of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -
  - (i) the holder of the premises licence,
  - (ii) the designated premises supervisor (if any) in respect of such a licence, or
  - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "valued added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted prie on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
  - (2) The permitted price which would apply on the first day applies to sales or supplies of

alcohol which take place before the expiry of the period of 14 days beginning on the second day. LICENSING CONDITIONS

The licence holder shall operate and maintain a refusals register in respect of declined sales of alcohol where the attempted purchaser was suspected of being under 18 years of age or drunk. The refusals register shall be kept on the premises and be made available immediately on request to an authorised officer of the Police or Local Authority.

A fully working and maintained CCTV system capable of recording and storing images must be installed on the premises. The system must record at all times the premises is open to the public and images must be stored for a minimum of 28 days with date & time stamping. As a minimum this must cover all entry and exit points, both sides of all areas where the sale/supply of alcohol takes place. All recordings must be made available to an officer from a responsible authority upon reasonable request and in line with the provisions of the Data Protection Act 1998.

The Recording equipment and tapes/discs shall be kept in a secure environment under the control of the DPS or other responsible named individual. An operational daily log report must be maintained endorsed by signature, indicating the system has been checked and is compliant, in the event of any failings actions to be taken are to be recorded. In the event of technical failure of the CCTV equipment the Premises Licence Holder/DPS MUST report the failure to the Police.

All staff involved in the retail of alcohol will be trained in relation to the law regarding its sale. This training must be completed prior to them being authorised to sell alcohol and refreshed every 12 months as a minimum. A record of this training must be kept and maintained with a copy of the syllabus attached. The recipient of the training must sign to state that they have received and understood the training and this should be dated. Training records must be kept on the premises at all times and made available to an officer from a responsible authority upon reasonable request.

Customers must not take open vessels of alcohol from the premises at any time unless there is an authorisation such as a street café licence in place. Where such an authorisation is in place open vessels of alcohol must not be taken beyond the boundaries indicated by the licence.

The premises will operate and adhere to an age verification scheme with the minimum standard of Challenge 25. Signs advertising the policy must be displayed in all areas where alcohol is for

Persons shall be discouraged from congregating outside of the premises.

Alcohol will only be served as an ancillary to a meal. Customers to be seated having ordered a 'substantial' meal.

The premises will conform to all statutory health and safety requirements.




