## **1.0** Purpose of Report

1.1 To consider a variation application in respect of Jimmy's Sports Bar, 6-10 Harlestone Road, Northampton, NN5 7AE. Premises Licence Number PL0419.

## 2.0 Summary

2.1 An online application was received from the premises licence holder Sandra Andrews on the 13<sup>th</sup> June 2019 for the variation of the above premises licence. This application did not meet with the statutory advertising requirements and as a result the application was rejected by licensing officers.

The applicant was informed of the reasons for the failure of the application and further guidance on the application process was emailed to the applicant on the 2<sup>nd</sup> July 2019.

A further online variation application was received on the 3<sup>rd</sup> July 2019 from the premises licence holder Sandra Andrews.

As part of the statutory requirement a copy of the application was served by the licensing authority onto the responsible authorities by email on the 4<sup>th</sup> July 2019.

## 3.0 Application Details

- 3.1 The variation application is requesting the additional licensable activity for;
  - live music

The application is also requesting extended permitted days/hours for;

- sale/supply of alcohol, and
- recorded music,

There is also a request to extend the opening hours in order to align with the requested licensable activity hours.

As part of the applicants operating schedule, the applicant has also submitted a number of steps that the licence holder has agreed to implement in order to promote the licensing objectives. A copy of the application including the operating schedule is detailed in **Appendix A**.

3.2 The current licensable activities and times are;

The applicant has been advised that the premises are currently not compliant with the personal licence mandatory condition as detailed in the email correspondence at **Appendix H**.

As a result, even though the Sub-committee must consider the application today and make such decision as it sees fit, until such time as the current designated premises supervisor becomes the holder of a personal licence, or the premises licence is varied to specify another person who does hold a person licence as the designated premises supervisor, the premises are not able to supply alcohol.

## 4.0 Plan of Premises Layout & Location

There are no changes to the plan proposed in the variation application. A copy of the existing plan is detailed in **Appendix B**.

## 5.0 Consultations/Representations

5.1 When a request for the variation of a premises licence or club premises certificate is received, the applicant must display a notice at or near the premises and serve a copy of the application onto the responsible authorities. For electronic applications it is a requirement of the local authority to serve a copy of the application onto the responsible authorities.

This gives responsible authorities and interested parties the opportunity to make representations in relation to the application for a period of 28 calendar days. The last date for making a representation was the 31 July 2019.

- 5.2 A notice was displayed on the premises as seen by a licensing officer on the 3 July 2019 and in a local newspaper on the 11 July 2019. Photographs of the notices displayed at the premises are contained in the representation set out in **Appendix C**. A copy of the newspaper notice is detailed in **Appendix F**.
- 5.3 It is recommended that, as a preliminary issue, the Sub-committee hears from the parties in relation to the steps taken to advertise the application and decides whether the statutory requirements have been met and, if not, whether there has been prejudice to any person who might be affected. If the Sub-committee is satisfied that these requirements have been met and there is no prejudice it should continue to consider the remainder of the report and hear from the parties in the usual manner. If the Sub-committee is not satisfied that the statutory requirements have been met and that there is prejudice to any person who might be affected then the Sub-committee must treat the application as not being properly made and, if the applicant wishes to proceed, they will need to commence the process again.
- 5.4 The Licensing Department has received one relevant representation under the licensing objective of public nuisance from a member of the public. The member of the public has raised issues regarding the statutory advertising requirements as detailed in the representation at **Appendix C**.
- 5.5 Northamptonshire police have considered the application and have come to an agreement on the licence conditions which they would wish to see added to the licence. The conditions agreed between the responsible authority and the applicant are detailed in **Appendix D**. As is always the case, even though the parties have indicated their agreement to the inclusion of these conditions, the final decision is for the Sub-committee to make as the Licensing Authority.
- 5.6 Environmental Protection have considered the licence application pertinent to the licencing objective of the prevention of public nuisance and have agreed conditions with the applicant as detailed in **Appendix E**. Again, even though the parties have indicated their agreement to these conditions, the final decision is for the Sub-committee to make.

## 6.0 Attendance

6.1 The local authority is required to send a notice of hearing to all interested parties and request confirmation of attendance. A notice of hearing was sent to the following persons on the 5 August 2019.

## 7.0 Options

- 7.1 At the end of the consultation period the licensing authority must hold a hearing. It must take such steps as it considers appropriate for the promotion of the licensing objectives, which are:
  - the prevention of crime and disorder;
  - public safety;
  - the prevention of public nuisance; and,
  - the protection of children from harm.

The steps the Sub-Committee can take are to:

- reject the whole or part of the application; or
- modify the conditions of the licence (excluding the mandatory conditions).

The conditions of the licence are modified if any of them are altered or omitted or any new condition added.

Training of all existing staff and new members of the team so they are aware of the premises license and the importance of promoting the 4 licensing objectives. This will include, but is not limited to, monitoring the supply of alcohol, ensuring staff are adopting the "think 25" practise and refusal to serve to intoxicated visitors. No violence or threatening behavior in or around the premises. Ensuring the illegal use of drugs is prohibited in or around the premises, notifying the police in the event that this was to ever happen. Manager of the site is in day to day control of the premises & appropriate training is provided across all staff. CCTV is in operation 24/7 with play back option available. The safety of our customers and the area of which we are located is of utmost importance to all employees at Jimmy's, we understand the importance of promoting the 4 licensing objectives together. On previous submission of an application to vary an existing premises license, we have received some advice from the licensing authority which we are already taking steps to put in place.

b) The prevention of crime and disorder

Jimmy's have security on the doors when there's events on at the weekend, dependent on the expected number of people, will have an impact of the number of security on site. Security remain on site until the premises is closed. We have CCTV 24/7 with live footage of all areas of the inside and outside of the building being shown behind the bar and on the owners phone. A play back option is available. Pool tables are covered and pool cues, darts and air hockey pucks are placed behind the bar during evenings. All items which could potentially be used as weapons are removed when events are on. Clear notices warning of potential criminal activity being reported to the police and will not be tolerated are displayed around

the building.

#### c) Public safety

Jimmy's Sports Bar complies with full standard statutory fire safety controls. All equipment within the building has regular safety maintenance checks with a log book kept on site with this information in.

We are at full capacity when we have 180 people in. To prevent overcrowding, at all events we expect to have over 100 people, we ensure we have security on the door with a click counter, stopping people from entering when we reach 180. Internal and external lighting is available with CCTV also monitoring internally & externally. There are signs located around the building clearly informing all customers that CCTV is in operation. All staff are trained in checking identification to prevent underage drinking.

d) The prevention of public nuisance

Once licensed hours are over all customers will have to leave the premises. Clear notices are displayed at the exit asking customers to exit quietly to respect nearby residents. All staff who leave at the end of the night are aware of the importance of leaving the premises quietly so as to not disturb nearby residents. All deliveries take place during the day time. Bins are emptied at mid day in the afternoon, no bottle bins will be emptied past 10pm in the evening.

#### e) The protection of children from harm

Children are only allowed on the premises until 9pm & they must be with someone over the age of 18. All staff are trained in checking identification, adopting the think 25 practise, with clear signs in the bar areas, only accepting passports, driving licenses or citizen cards. We also have UV lights available to identify fake identification which may be used. In the event of this happening staff are aware they must confiscate this identification and report to the police. Gambling machines are monitored to ensure the age restriction is adhered to.



  - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
  - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Licensing Act 2003 - Premises Licence Register as at 12:51 on 17 August 2019

(2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

## Licensing Act 2003

This licence is granted on the condition that the restrictions contained within the enactments specified under the Licensing Act 2003 Schedule 8 (1 & 6) are adhered to.

**Licensing Objectives** 

Below are the additional steps that you have agreed to undertake to promote the four Licensing Objectives and which form a part of the operating schedule for these premises: -

## Prevention of Crime & Disorder -

Entry is permitted by electronically controlled door following CCTV and intercom vetting. No open containers to be taken from the premises. No irresponsible drink promotions.

## Public Safety -

Regular safety check and log book kept. Regular checks of emergency exits and lighting.

## **Prevention of Public Nuisance -**

'Good Neighbour' signs displayed at the entrance/exit advising of acceptible behaviour. No opening windows (to contain noise).

## Protection of Children from Harm -

Proof of age cards. Children only permitted on the premises in company with an appropriate adult. All children to be off the premises by 9.00pm.

The following mandatory conditions are to be applied to the licence stated above in accordance with The Licensing Act 2003 (Mandatory Licensing Conditions) Order 2014.

## The following conditions shall come into force on 28th May 2014

**1.** A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

2. For the purposes of the condition set out in paragraph 1-

(a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979
(b) "permitted price" is the price page of the formula-

P = D + (DxV)

#### Where -

- (i) P is the permitted price,
- (ii) D is the rate of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;

(c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -

- (i) the holder of the premises licence,
- (ii) the designated premises supervisor (if any) in respect of such a licence, or
- (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;

(d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and

(e) "valued added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

**3.** Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

**4.** (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted prie on the next day ("the second day") as a result of a change to the rate of duty or value added tax.

(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

## ADDITIONAL MANDATORY CONDITIONS.

The following mandatory conditions are to be applied to the licence stated above in accordance with The Licensing Act 2003 (Mandatory Licensing Conditions) Order 2010 as amended by the The Licensing Act 2003 (Mandatory Licensing Conditions) (Amendment) Order 2014.

## The following conditions shall come into force on 1<sup>st</sup> October 2014

(1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

(2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises-

(a)games or other activities which require or encourage, or are designed to require or encourage, individuals to-

(i)drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or

(ii)drink as much alcohol as possible (whether within a time limit or otherwise);

(b)provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;

(c)provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;

(d)selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;

(e)dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

**2.** The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

**3.** (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

(2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

(3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either-

(a)a holographic mark, or

(b)an ultraviolet feature.

4. The responsible person must ensure that-

(a)where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-

(i)beer or cider: 1/2 pint;

(ii)gin, rum, vodka or whisky: 25 ml or 35 ml; and

(iii)still wine in a glass: 125 ml;

(b)these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and

(c)where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available."
