The press and public may only be excluded from such meetings as and when the Council's monitoring officer decides that this is necessary in order to avoid the public disclosure of confidential or exempt information (as legally defined). A key decision is defined as a decision which is likely:

- a) to result in the local authority incurring expenditure or the making savings in excess of £250,000 and/or
- b) to be considered significant in terms of its effect on a community
